### Remedy claimed or sought:

- Abridging the time for service of this Application and the supporting materials, as necessary, and deeming service thereof to be good and sufficient as outlined in the Affidavit of Service of Elvina Hussein.
- 2. Declaring that the interests of claimants against funds paid into Court or trust accounts pursuant to Court Orders, are to be determined in accordance with the priorities set forth in the *Bankruptcy* and *Insolvency Act* (the "BIA") and the *Income Tax Act*.
- 3. Approving the settlement between Deloitte Restructuring Inc., in its capacity as Trustee in Bankruptcy of the Plumb-Line Group, (the "Trustee") and Ashton Square Inc. and Ashton Luxury Living Inc., operating as Ashton Luxury Living (collectively referred to as "Ashton"), in the amount of \$150,000 (the "Funds") in full satisfaction of the amounts owing under the Builder's Lien filed by the Trustee and the Builder's Liens filed by Four Star Rock Products Ltd. and 1662995 Alberta Inc.
- 4. Directing Superior Concrete Systems Ltd. ("Superior") to discharge the Builder's Lien registered as Instrument No. 131 263 083 against the lands legally described as Plan 0813647, Block 14, Lot 21, forthwith.
- 5. Directing that the Provincial Court Action commenced by Superior Concrete System Ltd. against Plumb-Line Group Holdings Inc., Plumb-Line Group of Companies Inc., Con-Forte Contracting Company Inc. and Ashton Square Inc., as Action No. P1390104132 (the "Provincial Court Claim"), be discontinued forthwith.
- Such further and other relief as Counsel may seek.

#### Grounds of the Application:

- 7. The Plumb-Line Group, which includes Con-Forte Contracting Company Inc. ("Con-Forte") was assigned into bankruptcy on October 16, 2013 and October 18, 2013.
- 8. Due to the presence of a number of outstanding accounts receivable on the books and records of Con-Forte, the Trustee took the step of filing a builder's lien registration against the lands described as:

Plan 0813647
Block 14
Lot 20
Excepting thereout all mines and minerals

where Con-Forte provided services (referred to as the "Project").

- 9. Certain Sub-Lien Claimants also filed lien claims in respect of contract work done for Con-Forte on the same Project.
- 10. The lien registration by Superior as referenced above, is improper as it was against the wrong lands.
- The Trustee, with the approval of the Estate's Inspectors, has entered into a settlement agreement with Ashton, subject to approval of the Court and conditional upon payment of the settlement funds to the Trustee for distribution to Canada Revenue Agency ("CRA").
- 12. The Sub-Lien Claimants may claim priority to funds paid into Court or trust pursuant to the *Builders' Lien Act*, however, other creditors of Con-Forte (including CRA) claim priority under, *inter alia*, the BIA and the *Income Tax Act*.
- 13. The Provincial Court Claim is stayed by virtue of the bankruptcy and should not have been filed. Further, Superior has no claims against Ashton.
- 14. Such further and other grounds as counsel may advise.
