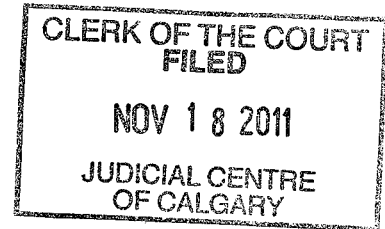



CONSENT ORDER

(Re: Adjournment of Receiver's November 10 Application)

UPON noting the application dated November 10, 2011 (the “**Application**”) of Deloitte & Touche Inc., in its capacity as Court-appointed receiver and manager of Perera Development Corporation (“**PDC**”) and Perera Shawnee Ltd. (“**PSL**”, or when reference is being made to PDC and PSL collectively, the “**Debtor**”), and not in its personal capacity (the “**Receiver**”); **AND UPON** noting the Affidavit of Service of Kelly Des Rochers, sworn and filed November 17, 2011 (the “**Affidavit of Service**”); **AND UPON** noting the Twenty-Fifth Report of the Receiver, dated and filed November 10, 2011 (the “**Twenty-Fifth Receiver's Report**”); **AND UPON** noting the consent of Counsel for the Receiver, Counsel for Don Lal Perera and Insight Dynamic Solutions Inc. (the “**Initial Purchaser**”), Counsel for Jerzy Maslanka and Krystyna Glowinska-Maslanka (collectively, the “**New Purchaser**”), ^{and} Counsel for the Plaintiff ~~and Counsel for the~~ ~~Defendants~~; **IT IS HEREBY ORDERED AND DECLARED THAT:**

4. The Initial Purchaser shall be available for cross-examination on the Affidavit on Monday, November 21, 2011 beginning at 3:00 p.m. at the office of Osler, Hoskin & Harcourt LLP in Calgary, Alberta.
5. This Order may be consented to in counterpart and by facsimile.




