TAKE NOTICE that an application will be made by the Petitioners to the Honourable Chief Justice at the Courthouse at 800 Smithe Street, in the City of Vancouver, in the Province of British Columbia, at ~~10:00~~ a.m. on May 15, 2009 or as soon thereafter as the application can be heard, for an Order: *AKB*

1. Confirming and extending the relief granted to the Petitioners in the Initial Order granted by this Court on April 15, 2009 and confirmed by Order made on April 15, 2009 (the "Initial Order") to 6:00 p.m. on June 15, 2009 or such later date as this Court may subsequently order;
2. Extending the stay of proceedings granted by the Initial Order to 6:00 p.m. on June 15, 2009 or such later date as this Court may subsequently order;

3. Granting such further and other corollary relief as this Honourable Court may deem just.

The Petitioners will rely on Sections 11(4) and 11(6) of the *Companies' Creditors Arrangement Act*, R.S.C. 1985, c. C-36, as amended, and the inherent jurisdiction of this Honourable Court.


At the hearing of the application, the Petitioners will rely on the pleadings and proceedings previously filed herein and the following additional affidavits and other documents:

2. Second Monitor's Report to be filed; and
