UPON THE APPLICATION of Deloitte Restructuring Inc., the Court-appointed CCAA Monitor and the Court-appointed Receiver (the "Receiver") of Village On The Park Inc. ("Village On The Park"); AND UPON being advised that Leposava Laban (the "Plaintiff") commenced an action seeking damages against Village On The Park, and other parties, in Court of Queen's Bench of Alberta, Action No. 1201-05843 (the "Laban Action"); AND UPON noting the consent hereto of counsel for the Plaintiff;

## IT IS HEREBY ORDERED AND DECLARED THAT:

## PARTIAL LIFTING OF STAY

- 1. The stay of proceedings ordered for the benefit of Village on the Park in paragraphs 8 10 (the "Stay") of the Receivership Order granted herein on December 12, 2017 (the "Receivership Order") is hereby lifted solely to permit the Laban Action to proceed against Village On The Park for the limited purpose of allowing the Plaintiff to continue to negotiate a settlement with Village On The Park, and if a settlement cannot be reached, allowing the Plaintiff to continue to take steps in the Laban Action.
- 2. Except as expressly provided in paragraph 3 below, the Stay remains in full force and effect in accordance with the terms thereof. For the avoidance of doubt, the Stay is not lifted against any party other than Village On The Park.
- 3. Any settlement, judgment, and/or award of costs that may be awarded against Village On The Park to the Plaintiff in the Laban Action may be satisfied only by recourse to any available insurance proceeds. The Plaintiff shall have no right to, and shall not, directly or indirectly, make any claim against, or seek any recoveries from. Village On The Park or its assets or property.

- 4. The Plaintiff shall seek the written consent of the Receiver or leave of this Court prior to serving any subpoena or appointment for questioning, interrogatories or written questions, or other process seeking any form of oral or written discovery or production from Village On The Park, or its current, former, or future directors, officers, employees, or agents.
- 5. If the Plaintiff, or any other person on her behalf, requires the Receiver's involvement or assistance with the settlement and/or the continuation of the Laban Action, the Plaintiff shall be responsible to pay for the Receiver's and its legal counsel's reasonable fees and disbursements relating to the Receiver's requested involvement or assistance.

## **GENERAL**

6. The Receiver shall be at liberty and is hereby authorized and empowered to apply to this Court for further advice, assistance, and direction as may be necessary to give full force and effect to the terms of this Order.
