#### **INTRODUCTION**

- On April 16, 2024, Deloitte Restructuring Inc. ("Deloitte") was appointed as Receiver and Manager (the "Receiver") over certain assets, undertaking and properties (the "Property") of Kelsey Lynne Fisheries Ltd. ("KLF") by Coastal Financial Credit Union Ltd. ("Coastal") pursuant to a collateral mortgage dated May 25, 2018 securing all present and future indebtedness of KFL on land and buildings located at 4106 Highway 308, Tusket, Nova Scotia (PID 90087362).
- 2. On January 4 2024, (the "Date of Bankruptcy"), the Supreme Court of Nova Scotia issued a bankruptcy order adjudging KLF in bankruptcy (the "Bankruptcy Order"). Under the Bankruptcy Order, Deloitte Restructuring Inc. ("Deloitte") was appointed as the Licensed Insolvency Trustee of KFL. Deloitte's appointment as Trustee was affirmed at the first meeting of creditors that was held on March 4, 2024.
- 3. On January 4, 2024, the Trustee took possession or control of the Property, which primarily consisted of:
