

NATURE OF APPLICATION

- Detoitte Restructuring Inc. (the "Receiver") was appointed Interim Receiver-Manager of the assets, property and undertaking of the Respondents (the "Companies") by Order of this Honourable Court dated May 18, 2006 (the "Receivership Order").
- By Order dated June 23, 2006, this Honourable Court authorized the Receiver to enter into an asset purchase agreement of certain assets (the "Property") with 54040 Newfoundland and Labrador Inc., on the terms and conditions set out in the Receiver's Report.
- The Receiver completed the sale of the Property to 54040 Newfoundland and Labrador Inc. pursuant to the June 23, 2006 Order of the Honourable Court.
- 4. By Order of the Honourable Mr. Justice O'Regan dated January 31, 2007 (the "January 31 Order"), the Receiver was authorized to make a distribution to the Bank of

Nova Scotia and to execute a claims plan to determine the rights and entitlements of potential priority creditors (the "Claims Plan"). In the January 31 Order the Court also approved accounts and conduct of the Receiver and its independent legal counsel Stewart McKelvey (previously Stewart, McKelvey, Stirling, Scales) as outlined in the Receiver's Second Report.

- 5. By Order of this Court dated October 26, 2007 (the "October 26 Order"), the Receiver was authorized to make a distribution to the Bank of Nova Scotia and to make distributions to the creditors identified from the Claims Plan. In the October 26 Order the Court also approved accounts and conduct of the Receiver and its independent legal counsel Stewart McKelvey as outlined in the Receiver's Third Report;
- 6. The Receiver has satisfied its mandate under the Receivership Order and subsequent Orders of this Honourable Court, and now seeks an Order:
 - (a) Approving the activities of the Receiver as set out in its Fourth Report to the Court;
 - (b) Approving the accounts of the Receiver and its legal counsel, both advisory (Stewart McKelvey) and litigation (Cain Lamarre LLP);
 - (c) Approving the distribution of Estate Funds as proposed by the Receiver and as set out in the Receiver's Fourth Report; and
 - (d) Discharging Deloitte Restructuring Inc. as Interim Receiver-Manager of the Companies.

PROCEDURAL HISTORY

- 7. The procedural history of this matter is as follows:
 - (a) The Applicant ("DRI") issued an Originating Application herein to be court appointed interim receiver;
 - (b) DRI was appointed as Interim Receiver-Manager pursuant to the Receivership

 Order dated May 18, 2006, by the Honourable Court;
 - (c) DRI filed its First Receiver's Report with this Honourable Court dated June 19, 2006, its Second Receiver's Report dated January 19, 2007, and its Third Receiver's Report dated October 19, 2007;

- (d) This Honourable Court made orders in relation to the Receiver's Reports, which orders were dated June 23, 2006, January 31, 2007 and October 26, 2007; and
- (e) The Applicant filed and served a Notice of Intention to Proceed with this Honourable Court on or about December 28, 2022.

MATERIAL FACTS

- 8. Following the issuance of the Receivership Order, the Receiver took possession of the Property in accordance with its mandate from the Court.
- The Receiver remained in possession and management of the Property up until the completion of the sale of the Property.
- 10. The Receiver received payment of net sale proceeds generated by the sale of the Property, ran its Claims Plan to completion and has now settled all outstanding litigation, all as reported in its Fourth Receiver's Report as filed contemporaneously with this Application. The Receiver has also held discussions with Canada Revenue Agency ("CRA") and filed all necessary statutory tax returns to bring the Debtor's and Receiver's accounts into compliance. As part of these discussions, the Receiver has collected refunds from CRA which form part of the Estate Funds to be distributed as set out in Appendix "B" to the Receiver's Fourth Report.
- 11. The Receiver holds \$1,220,023.35 in trust (the "Estate Funds") as of the date of its Fourth Report.
- 12. The Receiver seeks the approval of this Honourable Court to proceed with the distribution of the Estate Funds as set out in the Receiver's Fourth Report, including the accounts of the Receiver and its counsel.
- 13. The Receiver considers that it has satisfied its mandate under the Receivership Order and the subsequent Orders of this Honourable Court.
- 14. DRI respectfully requests to be discharged from its role as Interim Receiver-Manager of the Companies.

RELIEF SOUGHT

The Receiver requests an Order:

- (a) Approving the activities of the Receiver as set out in the Receiver's Fourth Report to the Court;
- (b) Approving the accounts of the Receiver as set out in Appendix "D" to the Receiver's Fourth Report;
- (c) Approving the accounts of counsel for the Receiver, both advisory and litigation, as set out in Appendices "E" and "F", respectively, of the Receiver's Fourth Report;
- (d) Approving the distribution of the Estate Funds as proposed by the Receiver and set out in the Receiver's Fourth Report; and
- (e) Discharging DRI as Interim Receiver-Manager of the Companies.
