UPON THE APPLICATION of NRG Divestitures Inc. ("NRG"); AND UPON having read the Affidavit of Stephen Henrich, sworn August 20, 2015 (the "Henrich Affidavit"), the Pre-Filing Report dated August 7, 2015, of Deloitte Restructuring Inc. ("Deloittes"), and such other material in the pleadings and proceedings as are deemed necessary; AND UPON hearing counsel for the Applicant, counsel for Deloittes in its capacity as receiver of the undertaking,

property and assets of Sekur Energy Management Corp. ("Sekur", and Deloittes, in such capacity, the "Receiver"), and other interested parties;

IT IS HEREBY ORDERED AND DECLARED THAT:

- 1. The time for service of notice of this Application is abridged to the time actually given and service of the Application and supporting material as described in the Affidavit of Stacy Bilodeau sworn September 10, 2015, is good and sufficient, and this hearing is properly returnable before this Honourable Court today and further service thereof is hereby dispensed with.
- 2. The Receiver is authorized to pay to NRG:
 - (a) an aggregate commission of \$35,700 in respect of sales by the Receiver to Signalta Resources Limited, Twin Butte Energy Ltd. and Head First Energy Inc. completed by approval and vesting orders of the Honourable Madam Justice K.M. Horner pronounced on August 12, 2015;
 - (b) a commission equal to 6% of the purchase price payable by Response Energy Corporation ("Response") in relation to a proposed sale of certain assets of Sekur by the Receiver to Response;
 - (c) a commission equal to 3% of the purchase price payable by purchasers in connection with all other sales by the Receiver of assets of Sekur, but excluding sales to those entities listed on Schedule "C" to the agreement between NRG and Sekur, dated May 7, 2015 (the "Excluded Parties"); and
 - (d) a commission equal to 1% of the purchase price payable by Excluded Parties in connection with sales by the Receiver of assets of Sekur.
- 3. All commissions the Receiver is authorized to pay to NRG pursuant to this Order, including any good and services tax thereon, shall only be payable by the Receiver on the completion of such transaction.
