#### Hi Jerritt

In addressing the "puzzle' that lies before us, it is my understanding that Adrenaline as a secured creditor <u>with</u> <u>possession</u> of the vehicle is not bound by the Stay. Per 69(2) of the BIA, and confirmed I believe by your attachment, the Stay does not apply to prevent Adrenaline, who took possession of secured asset prior to the notice. The BIA defines a "Secured Creditor" as a person holding a . . . lien on or against the property.

It is my further understanding that it Adrenaline has to take steps to seize and sell within 6 months of their lien being filed; accordingly, they should instruct the appropriate authority to seize the vehicle asap. With respect to extending time past the 6 months that in my view applies only if there is needed more time to seize the vehicle but the appropriate steps to seize have to be taken.

I note that the notice states approximately \$55K in unsecured debt re Adrenaline. My understanding is that \$27K, more or less, of the \$55K is secured (the lien). If the asset were sold then Adrenaline takes their \$27K plus and the remainder goes into the unsecured pot.

I confirm that our client wants to proceed in an amicable and cost effective manner. They understand that Prairie would like the tractor returned so as to generate revenue to assist them in their current state of finances. Accordingly, picking your brain, is there some form of Order / agreement (standstill or other) that we can put into place that effectively confirms and protects our client as a "secured creditor". Then the process – proof of claim, etc. can be followed with the chance that Prairie gets the opportunity to have the tractor returned (of course subject to the indebtedness re the tractor being paid.

You will note I have copied this email to Brennan (another lawyer in the office) for his input – he may be taking conduct of this matter.

As you are aware, we act as restructuring counsel to 915245 Alberta Ltd. (O/A Prairie Tech Oilfield Services) ("**Prairie Tech**"). We are writing to address the status of the vehicle described as Peterbilt 389, model year 2016, identified as VIN: 1NPXD49X9GD305583 (the "**Vehicle**") in light of Prairie Tech's recent filing of a Notice of Intention to Make a Proposal ("**NOI**") pursuant to section 50.4 of the *Bankruptcy and Insolvency Act*, RSC 1985, c B-3 (the "**BIA**").

As we understand it, Prairie Tech left the Vehicle with your client, 1635623 Alberta Inc. (O/A Adrenaline Diesel)("**Adrenaline**") and authorized Adrenaline to complete or perform maintenance or repairs to, or in respect of, the Vehicle. We further understand that Prairie Tech did not make payment of the account rendered by Adrenaline for such works prior to the filing of its NOI on February 22, 2022.

We are writing to reiterate that the general stay of proceedings imposed upon all creditors of Prairie Tech pursuant to section 69 of the BIA automatically upon the filing of the NOI prohibits Adrenaline from taking any steps whatsoever to enforce any security that it may have in the Vehicle pursuant to the *Garage Keepers' Lien Act*, RSA 2000, c G-2 (the "**GKLA**"), or from pursuing any other remedies against Prairie Tech. BIA Section 69(1)(a) provides as follows:

69 (1) Subject to subsections (2) and (3) and sections 69.4, 69.5 and 69.6, on the filing of a notice of intention under section 50.4 by an insolvent person,

# (a) no creditor has any remedy against the insolvent person or the insolvent person's property, or shall commence or continue any action, execution or other proceedings, for the recovery of a claim provable in bankruptcy;

*Per* your email to the undersigned, dated March 4, 2022, we understand that you take the position that the stay imposed by BIA section 69 is not operative in respect of Adrenaline's right to take enforcement steps against the Vehicle due to the operation of an exception set out in BIA section 69(2)(a), which provides as follows:

(2) The stays provided by subsection (1) do not apply

# (a) to prevent a secured creditor **who took possession of secured assets** of the insolvent person **for the purpose of realization** before the notice of intention under section 50.4 was filed **from dealing with those assets**;

A close reading of BIA section 69(2)(a) shows that the exception outlined therein is only operative in respect of secured creditors who have seized assets encumbered by the creditor's security for the purpose of realization. Adrenaline neither seized the Vehicle nor did it acquire possession of it "for the purpose of realization" prior to the filing of the NOI. Indeed, the GKLA expressly outlines the process required for a lien claimant to seize a vehicle for the purposes of enforcement - GKLA sections 6(2), 8 and 9 collectively impute the procedure for seizure set out in the *Civil Enforcement Act*, RSA 2000, c C-15 (the "**CEA**"), into the GKLA. As we understand it, Adrenaline did not take any of the steps set out in the CEA to effect seizure of the Vehicle prior to the filing of the NOI. Consequently, Adrenaline has not taken possession of the vehicle "for the purpose of realization" within the meaning of the BIA.

As the exceptional provision set out in BIA section 69(2)(a) is not operative, Adrenaline is barred from continuing any debt enforcement action against Prairie Tech and it is not in a position to take any enforcement steps whatsoever against Prairie Tech including, without limitation, seizure.

Consequently, we were both surprised and disappointed to discover that Adrenaline purported to effect the seizure of the vehicle on March 21, 2022, despite the fact that we had previously referred you to the provisions of the BIA governing the stay of proceedings imposed against Adrenaline pursuant to section 69 of the BIA.

Adrenaline's flagrant disregard for the stay of proceedings imposed against the creditors of Prairie Tech is both tantamount to contempt of a Court Order and constitutes a breach of Adrenaline's duty to act in good faith in connection with these proceedings pursuant to section 4.2(1) of the BIA.

Take note that we have already scheduled a hearing before a Justice on the Commercial List for the Court of Queen's Bench of Alberta scheduled for 10:00 a.m. on April 6, 2022. In due course, you will receive service of our Application seeking an Order requiring the vehicle to be turned over by Adrenaline to Prairie Tech forthwith. Additionally, we intend to seek a declaration that Adrenaline has acted in bad faith in violation of BIA section 4.2(1) and an Order awarding Prairie Tech the costs of its Application, payable forthwith pursuant to BIA section 4.2(2).

Take note that Prairie Tech is not seeking to extinguish the lien impressed against the vehicle by virtue of taking possession of the same. That Adrenaline maintains a lien against the Vehicle (albeit one that

is unenforceable during the pendency of these proceedings) pursuant to the GKLA is not disputed by Prairie Tech.

We ask that you contact the undersigned at your earliest opportunity should Adrenaline wish to avoid the necessity of the above-described Application by simply arranging for the return of the Vehicle to Prairie Tech.

We trust Prairie Tech's position concerning the status of the vehicle is made clear from the foregoing.

We act as solicitors for 915245 Alberta Ltd. (O/A Prairie Tech Oilfield Services) ("**Prairie Tech**"). We are writing concerning the following equipment:

(Collectively, the "**Equipment**")

We understand that Bonnie's Equipment Services Ltd. ("**Bonnie's**") is in possession of the Equipment and that it has refused to return the same to Prairie Tech. For reasons explained below, Bonnie's is not entitled to retain the Equipment and is obligated to turn over the same to Prairie Tech immediately.

#### Units 304, 310, 388, and 398

Prairie Tech acknowledges that Bonnie's performed maintenance or repairs to Units 304, 310, 388, and 398. Prairie Tech further acknowledges that accounts owing in respect of such repairs, and other services performed by Bonnie's, remain outstanding. Prairie Tech also does not dispute that Bonnie's maintains a lien against Units 304, 310, 388, and 398 pursuant to the *Garage Keepers' Lien Act*, RSA 2000, c G-2 (the "**GKLA**").

On February 22, 2022, Prairie Tech filed a Notice of Intention to Make a Proposal ("**NOI**") pursuant to section 50.4 of the *Bankruptcy and Insolvency Act*, RSC 1985, c B-3 (the "**BIA**"). Prairie Tech is not bankrupt, but is rather seeking to restructure its affairs in a Court-supervised proceeding in the matter of Court File No. 24-2806908 before the Court of Queen's Bench of Alberta.

By operation of law, Prairie Tech is also currently prohibited from making payments of any debts incurred prior to the filing of its NOI on February 22, 2022. This is to say, Prairie Tech is not able to make any payment to Bonnie's owing in respect of its past-due accounts at this time. Such debts are not extinguished. The terms of Prairie Tech's payment of debts to Bonnie's and its other creditors will be addressed in its Proposal that will ultimately be presented to its creditors in its restructuring proceedings.

Pursuant to section 69(1)(a) of the BIA, all creditors of Prairie Tech, inclusive of Bonnie's, are legally prohibited from commencing or continuing any enforcement action against Prairie Tech. The relevant section of the BIA reads as follows:

69 (1) Subject to subsections (2) and (3) and sections 69.4, 69.5 and 69.6, on the filing of a notice of intention under section 50.4 by an insolvent person,

(a) no creditor has any remedy against the insolvent person or the insolvent person's property, or shall commence or continue any action, execution or other proceedings, for the recovery of a claim provable in bankruptcy;

As Bonnie's is legally prohibited from commencing or any enforcement action against Prairie Tech, it is not legally permitted to continue to hold Units 304, 310, 388, and 398, as security for payment pursuant to the GKLA. Bonnie's is, therefore, required to return Units 304, 310, 388, and 398 to Prairie Tech.

Prairie Tech does not take the position that the return of Units 304, 310, 388, and 398 will extinguish Bonnie's claim of lien pursuant to the GKLA in such property.

#### <u>The TJ500</u>

We understand that Bonnie's has refused to return the TJ500 to Prairie Tech, notwithstanding the fact that Bonnie's has not performed any repairs to or in respect of the TJ500. As Bonnie's has not serviced the TJ500, it is not entitled to a lien in the TJ500 pursuant to the GKLA or any other source of law. Bonnie's is thus not entitled to hold the TJ500 as security for payment from Prairie Tech.

Bonnie's retention of the TJ500 is unlawful and Prairie Tech maintains a right to claim damages against Bonnie's for its loss of use of the TJ500.

#### Forthcoming Application for Recovery of the Equipment

Prairie Tech intends to bring forward an Application to the Court of Queen's Bench for a Court Order requiring the immediate return of the Equipment to Prairie Tech. A hearing has been scheduled for 10:00 a.m. on April 6, 2022. You will receive service of an Application and related materials in due course. Prairie Tech reserves the right to seek an award of costs against Bonnie's in the forthcoming Application.

We ask that you contact the undersigned at your earliest opportunity if you wish to make arrangements to return the Equipment to Prairie Tech so as to avoid the necessity of the forthcoming Application.

We trust Prairie Tech's position concerning the status of the Equipment and its right to possession of the same is made clear by the foregoing. This is an urgent matter and we strongly suggest that you bring it to the attention of your solicitor immediately.
