**NOTICE AND STATEMENT OF THE RECEIVER  
(Subsections 245(1) and 246(1) of the Act)**

The Receiver gives notice and declares that:

1. On August 10, 2015, I, Deloitte Restructuring Inc., became the receiver (“**Receiver**”) in respect of all properties (the “**Property**”) of Abond Corporation Inc. (“**Abond**”), insolvent person.
2. As of the date of this notice, the Property of Abond includes notably the following:
  - Accounts receivable (book value of \$3,914,086);
  - Inventory (book value of \$1,929,907);
  - Office equipment (estimated market value of \$34,470);
  - Equipment (estimated market value of \$140,675).
3. The Receiver was appointed in that capacity by the Superior Court of Québec, Commercial division, pursuant to an order rendered on August 10, 2015.
4. The Receiver took possession or control of the Property described above on August 10, 2015.

5. The following information relates to the receivership:

- a) The head office and the principal place of business of the insolvent person are located at 10050 Côte-de-Liesse Road, Montréal QC H8T 1A3.
- b) Abond is a company known as a manufacturer and distributor of specialty products for babies.
- c) The exact indebtedness of Abond to its secured creditor, which hold a security over the Property described above in a estimated amount of \$1,300,000.00, remains to be determined.
- d) The list of other creditors of Abond is presented in the appendix. The amount due to each of those creditors as well as the total amount owed by Abond remain to be determined.
- e) The intended plan of action of the Receiver, where the Receiver considers it necessary, during the receivership is as follows (please note that this plan of action is subject to change from time to time according to the circumstances):

- To control Abond's receipts and disbursements;
- To manage, operate, and carry on Abond's operations, if necessary;
- To take all measures necessary in order to protect and preserve the Property's value;
- To collect all of the accounts receivable and other claims of Abond, and to transact in respect of same, as well as to sign any document for this purpose;
- Petition the Court for the issuance of a vesting order to convey the Property free and clear of any liens or encumbrances affecting such Property;
- Retain whatever services required, in the opinion of the Receiver acting reasonably, to fulfill its mandate.
