Remedy claimed or sought:

- 1. Declaring service of notice of this application and the supporting materials to be good and sufficient, and abridging the time therefor, if necessary.
- 2. An Order substantially in the form attached to this Application as Schedule "A", granting an extension to the stay period in these proceedings (the "Stay Period") under the provisions of the Companies' Creditors Arrangement Act, RSC 1985, c C-36, as amended (the "CCAA") in relation to Medican (Westbank) Development Ltd. and Medican (Westbank) Land Ltd. (collectively, the "Kaleido Companies"), and Sanderson of Fish Creek (Calgary) Developments Ltd. ("Sanderson") to and including November 30, 2012.
- 3. Such further and other relief as may be necessary and appropriate in these proceedings.

Grounds for making this application:

Extension of the Stay Period

- 4. The Petitioners are seeking an extension of the Stay Period to November 30, 2012.
- 5. Since the last extension was granted in these proceedings on July 27, 2012, the Petitioners have continued working closely with the Monitor and the CRO to advance the restructuring, including by the various activities outlined in the Twentieth Report of the Monitor.
- 6. Sanderson is currently engaged in the construction and development of a multi-phase condominium project (the "Sanderson Project"). Sanderson has a net profit interest contingent upon the completion of the Sanderson Project (the "NPI"). The NPI is a valuable asset of Sanderson and is critical to its successful emergence from the CCAA proceedings.
- 7. A number of legal issues are affecting the completion of the Sanderson Project and are currently unresolved. These issues exist primarily between Sanderson and Monarch Land Ltd. ("Monarch"), Aviva Insurance Company of Canada, represented by its agent National Home Warranty Group Inc. (collectively "NHW") and the Sanderson Condo Corporation ("Condo Corp."). These issues will need to be litigated, and are described in more detail in the Affidavit of Tyrone Schneider, filed August 28, 2012.
- 8. A schedule for the litigation of these issues has been proposed, which assumes these matters will be properly resolved in advance of November 30, 2012.

- It is reasonable, appropriate and necessary in the circumstances to extend the Stay Period to November 30, 2012. The Petitioners continue to sell units and work with the Monitor in these proceedings.
- 10. The Petitioners continue to work in good faith and with due diligence in these proceedings and it is in the best interests of the Petitioners and all of the stakeholders that the extension be granted in the manner sought herein.

- 11. Affidavit of Tyrone Schneider, dated August 28, 2012 (the "Schneider Affidavit").
- 12. The Twentieth Report of the Monitor.
- 13. Other pleadings and materials previously filed in these proceedings.
