#### THE COURT:

- [9] **GRANTS** the Application.
- [10] **DECLARES** that all capitalized terms used but not otherwise defined in the present Order (this "**Order**") shall have the meanings ascribed to them in the Initial Order.

#### **Service**

- [11] **ORDERS** that any prior delay for the presentation of the Application is hereby abridged and validated so that the Application is properly returnable today and hereby dispenses with any further service thereof.
- [12] **PERMITS** service of this Order at any time and place and by any means whatsoever.

### **Extension of the Stay Period**

[13] **EXTENDS** the Stay Period and the application of the Initial Order until September 24, 2021.

## **Approval of the Monitor's activities**

- [14] **APPROVES** the activities of the Monitor, up to the date of the present Order in connection with the Restructuring, including the activities described in the Seventh Report of the Monitor dated June 11, 2021 and **DECLARES** that the Monitor has fulfilled its obligations pursuant to the CCAA and the orders of this Court up until the date of this Order.
- [15] **ORDERS** that Appendices A, C and D to the Seventh Report of the Monitor dated June 11, 2021 in support of the Application are confidential and are filed under seal, and **ORDERS** the Debtors to communicate any of said appendices to any creditor that signs a confidentiality agreement acceptable to the Debtors and said creditor, subject to the Court's final decision on any contestation.
- [16] **ORDERS** the provisional execution of this Order notwithstanding appeal, and without requirement to provide any security or provision for costs whatsoever.
- [17] **THE WHOLE** without legal costs.
