**RE: Medipure Holdings Inc.  
Medipure Pharmaceuticals Inc.**

Take notice that on August 19, 2022, Medipure Holdings Inc. and Medipure Pharmaceuticals Inc., (collectively, the "**Petitioners**" or "**Medipure**") sought and obtained protection pursuant under the *Companies' Creditors Arrangement Act* (the "**CCAA**") before the Supreme Court of British Columbia (the "**Court**").

Deloitte Restructuring Inc. ("**Deloitte**") has been appointed as monitor in the Petitioners' CCAA proceedings (the "**Monitor**") pursuant to the Initial Order of the Court dated August 19, 2022 (the "**Initial Order**"). These proceedings (the "**CCAA Proceedings**") are a continuation of the proceedings (the "**BIA Proceedings**") which commenced on May 11, 2022, pursuant to Part III, Division I of the *Bankruptcy and Insolvency Act*, R.S.C. 1985, c. B-3, as amended (the "**BIA**") under which Deloitte was appointed as the proposal Trustee of the Companies (the "**Proposal Trustee**"). The Initial Order discharges Deloitte as the Proposal Trustee of the Companies under the BIA Proceedings.

The Initial Order provided, among other things, for an initial stay of proceedings until August 22, 2022 (the "**Initial Stay**"). On August 22, 2022 the Court approved an amended and restated initial order (the "**ARIO**") which, among other things, appointed a chief restructuring officer and extended the Initial Stay to August 24, 2022. The Court may provide further extensions from time to time.

During a stay of proceedings, all parties are prohibited from commencing or continuing legal or enforcement actions against the Petitioners and all rights and remedies of any party against or in respect of the Petitioners or its assets are stayed and suspended except with the written consent of the Petitioners and the Monitor or leave of the Court.

Included in this package is a list of creditors with claims exceeding \$1,000 and was prepared based on information available from the Petitioners' books and records as of August 24, 2022. Creditors are not required to file a proof of claim form at this time.

The Monitor will post additional documents, including its reports to the Court on the Monitor's Website as they become available, and interested parties are encouraged to refer to the Monitor's Website frequently for updates on the status of the CCAA Proceedings.
