I, ROBERT DAVID KOFMAN, Co-President of RSM Richter Inc., of the City of Toronto, in the Province of Ontario, MAKE OATH AND SAY:

- 1. I am Co-President of RSM Richter Inc. ("Richter") and a partner of RSM Richter LLP ("Toronto Partnership"), as well as a licensed Trustee and as such I have knowledge of the matters deposed to herein.
- 2. This Affidavit is sworn in support of an application for the substitution of RSM Richter Inc. in its capacity as Trustee in Bankruptcy with Ernst & Young Inc. in respect of certain ongoing matters, as well as the transfer of all property and trust accounts relating to such mandates.
- On December 2, 2011, Ernst & Young Inc. ("EYI") acquired the assets used by audit, accounting, transactional advisory and tax professionals of the Toronto Partnership as well as the insolvency and restructuring assets used in the Province of Alberta ("EYI Transaction"). On the same day, Konstantinos (Gus) Tertigas, formerly of Richter and a licensed Trustee, became an employee of EYI

("EYI Restructuring Professional"). Attached as Exhibit "A" are press releases announcing this acquisition.

- 4. In connection with the acquisition of the insolvency and restructuring assets used in the Province of Alberta, on Monday, December 5, 2011, a motion was brought before the Alberta Court of Queens Bench seeking the transfer of open insolvency and restructuring mandates in the Province of Alberta from Richter to EYI. Attached as Exhibit "B" is the sworn affidavit of Robert Taylor in connection with that motion. Also attached as Exhibit "C" is a copy of the issued and entered order of the Alberta Court of Queens Bench in respect of that motion.
- There are two bankruptcies in Ontario related to the Alberta restructuring practice where Richter has been appointed as trustee in bankruptcy which will also be transferred to EYI. Those estates are: Envision Engineering & Contracting Inc., OSB File No.: 33-1474256; Landex Construction Inc., OSB File No.: 33-1474264 ("EYI Ontario Mandates"). In connection with the EYI Transaction, Richter is seeking to have EYI substituted as the trustee in bankruptcy in respect of the EYI Ontario Mandates.
- 6. All property, books, records and files relating to the EYI Ontario Mandates will also be transferred to EYI, as well as, all bank accounts, including trust accounts, related to the EYI Ontario Mandates. Public documents relating to EYI Ontario Mandates will be available on the EYI website.
- 7. Richter was engaged as financial advisor to representative counsel for all former employees and disabled employees ("Representative Counsel") in the

CCAA proceedings (the "Nortel CCAA Proceedings") of Nortel Networks Corporation and its affiliates (the "Nortel Debtors"), Court File No. 09-CL7950 (the "Nortel Mandate"). Pursuant to the order appointing Representative Counsel, all the fees and disbursements in respect of the Nortel Mandate are paid by the Nortel Debtors. In connection with the E&Y Transaction, Richter has transferred and assigned the Nortel Mandate to a subsidiary of EYI. I have been advised that the Nortel Mandate is to continue to be handled by the EYI Restructuring Professional and other former Richter accounting/or and advisory professionals who are now at EYI. I understand that EYI is the Court appointed Monitor in the Nortel CCAA Proceedings and EYI has implemented procedures to address concerns regarding the transfer of information and independence in respect of both roles. All books, records and files relating to the Nortel Mandate will be transferred by Richter to EYI.

ORDER

UPON the application of RSM Richter Inc. ("RSM"), and upon reading the Affidavit of Robert J. Taylor, and upon hearing counsel for RSM;

AND WHEREAS by numerous orders of the Court of Queen's Bench of Alberta, RSM is an officer of the Court, including but without limitation, appointments as a receiver, a receiver-manager, an interim receiver, a monitor, or other court appointed agent or representative (the "Court Officer") with respect to a number of open Alberta Court of Queen's Bench files;

AND WHEREAS RSM is the Trustee in Bankruptcy or Proposal pursuant to the *Bankruptcy and Insolvency Act* (Canada) (the "Trustee") with respect to a number of open Alberta Court of Queen's Bench files;

AND WHEREAS RSM is an agent or privately appointed receiver and/or manager (the "Private Receiver") with respect to a number of open Alberta Court of Queen's Bench files;

IT IS ORDERED:

- That Ernst & Young Inc. ("EY") be substituted in place of RSM, as Court Officer, Trustee or Private Receiver (collectively the "Insolvency Professional") with respect to all of the matters set out in the attached Schedule "A" (hereinafter referred to as the "Subject Files").
- 2. That the requirement for a separate Notice of Motion and supporting Affidavits to be filed in the Court file of each of the Subject Files be waived.
- 3. That the requirement for notification of this application to any party, including proven creditors within the Subject Files, be waived.
- 4. That the requirement and responsibility for taxation of RSM's accounts in respect of the Subject Files, from the initial date of appointment of RSM or another party as Insolvency Professional respecting the Subject Files through to the completion of the administration and discharge of RSM, is hereby assigned and transferred to EY.
- 5. That the requirement for taxation of the accounts of RSM in respect of the Subject Files is hereby waived.
- 6. That RSM be discharged as Insolvency Professional of the Subject Files without prejudice to the rights of the Superintendent of Bankruptcy or other professional body, to commence or pursue any professional conduct matters relating to the Subject Files, and:
 - (a) without having to certify to the court that it has observed all of the terms as provided by Rule 61(2) of the BIA; and
 - (b) without having to undertake to keep all estate books, records and documents as provided by Rule 68 of the BIA.
- 7. That EY is now required to observe all the terms provided by Rule 61(2) of the BIA, keep all estate books, records and documents as provided by Rule 68 of the BIA, obtain from the former trustee all books, estate records, documents including work in progress, billing or time records in support of any claims made for time charges and advances on fees made by the former trustee, and detailed trial balances (electronic or otherwise) from the date of bankruptcy or proposal showing all the funds received and disbursed since the initial appointment of RSM or another party as Insolvency Professional respecting the Subject Files, notwithstanding EY assuming responsibility for the Subject Files as at the date of this Order.
- 8. That the requirement for notification of the discharge of RSM as Insolvency Professional, together with other statutory notices to proven creditors, the bankrupt(s), debtors, the court and the Office of the Superintendent of Bankruptcy, be waived.
- 9. The clerk of the Court shall accept a copy of this Order to be filed in the Court for each of the Subject Files where a court file is required to be opened.
- 10. To the extent that RSM has given security in cash or by bond of a guarantee company pursuant to s.16(1) of the BIA (the "Security"), such Security shall be transferred from RSM to EY and any party holding such Security is hereby directed to take all steps necessary to effect such transfer.

Upon transfer, EY shall assume, and RSM shall be relieved of, all obligations respecting the Security.

11. Upon being presented with a filed copy of this Order, the Registrar of the Land Titles Office (Alberta) shall amend any encumbrance registered against title by RSM to replace RSM with EY as the party having registered the said encumbrance.

- I am a Vice President of RSM Richter Inc. ("RSM") and, as such, I have personal knowledge of the matters hereinafter deposed to except where stated to be based upon information and belief, in which case I verily believe the same to be true.
- 2. Attached hereto and marked as Exhibit "A" is a complete listing of all open Alberta Court of Queen's Bench files wherein:
 - a. by numerous orders of the Court of Queen's Bench of Alberta, RSM is an appointed officer of the Court, including but without limitation, appointments as a receiver, a

receiver-manager, an interim receiver, a monitor, or other court appointed agent or representative (the "Court Officer");

- b. RSM is the Trustee in Bankruptcy or Proposal pursuant to the *Bankruptcy and Insolvency Act* (Canada) (the "Trustee"); and
- c. RSM is an agent or privately appointed receiver and/or manager with respect to a number of entities (the "Private Receiver").
- 3. RSM is the court appointed receiver and manager in respect in action Q. B. G. No. 2131 of 2005 (Judicial Centre of Regina) involving Meadow Lake Pulp Limited Partnership and related entities (the "Meadow Lake Action").
- 4. The files described in paragraph 2 and the Meadow Lake Action are collectively referred to as the "Subject Files".

UPON READING the motion materials of Richter, including the Affidavit of Robert David Kofman, sworn December 6, 2011, together with the exhibits attached thereto, filed, and upon hearing the submissions of counsel for Richter, no one else appearing or having been served:

- 1. THIS COURT ORDERS that Ernst & Young Inc. ("EYI") be and hereby is substituted in place of Richter, as Trustee in Bankruptcy ("Trustee"), of the following estate files: Envision Engineering & Contracting Inc., OSB File No.: 33-1474256; Landex Construction Inc., OSB File No.: 33-1474264 (the "Subject Estates"), with effect from the effective date of this Order.
- 2. THIS COURT ORDERS AND DIRECTS that all real and personal property wherever situate of the Subject Estates is hereby vested in EYI in its capacity as Trustee in Bankruptcy, to be dealt with by EYI in accordance with the provisions of the Bankruptcy and Insolvency Act (Canada) (the "BIA"), pursuant to its powers and obligations as Trustee of the Subject Estates.

- 3. **THIS COURT ORDERS** that this Order shall be effective in all judicial districts in Ontario which govern any of the Subject Estates.
- 4. **THIS COURT ORDERS** that the requirement for a separate Notice of Motion and supporting Affidavit to be filed in the Court file of each of the Subject Estates is hereby waived.
- 5. **THIS COURT ORDERS** that the requirement for notification of this motion to proven creditors within the Subject Estates, the applicable bankrupts or debtors within the Subject Estates, and any other person is hereby waived.
- 6. THIS COURT ORDERS that EYI is authorized and directed to continue and to complete the administration of the Subject Estates and to deal with the Subject Estates' property, in accordance with the duties and functions of a Trustee, as the case may be, as set out in the BIA, and to receive all remuneration of the Trustee in the Subject Estates for services performed from the commencement of each of the Subject Estates until the discharge of the Trustee, less any remuneration already received by Richter in accordance with the provisions of the BIA.
