NOTICE AND STATEMENT OF THE RECEIVER
(Subsections 245(1) and 246(1) of the *Bankruptcy and Insolvency Act* (“BIA”))

The Receiver gives notice and declares that:

1. On September 30, 2014, Samson Bélair/Deloitte & Touche Inc. (“**Deloitte**”) was appointed to act as Receiver to all the assets, undertakings and properties (the “**Property**”) of 9150-3961 Québec Inc. (“**Viau**”) pursuant to a receivership order rendered under Section 243 of the BIA by the Superior Court of Québec, Commercial Division (the “**Receivership Order**”).
2. As of the date of the present notice, the Property of Viau subject to the Receivership Order contains notably the following assets, the value of which is to be determined:
 - Cash;
 - Accounts receivable;
 - Inventories;
 - Rights in intangible assets (name, intellectual property, contract, and others);
 - Equipment and tools;
 - Furniture and fixtures.
3. In accordance with an interim receiver order rendered on September 26, 2014 (“**Interim Receivership Order**”), Deloitte, acting as an interim Receiver, took the necessary measures to monitor the receipts and disbursements of Viau and to protect the Property described in paragraph 2 above.


4. In accordance with the Receivership Order dated September 30, 2014, the Receiver (Deloitte) took control of the Property, including the control of receipts and disbursements.
5. The following information relates to the present receivership:
- a) The registered address of Viau is 8725 Viau Street, Montreal, Quebec, H1R 2T9;
 - b) Viau's business is a grocery store operating under the name Intermarché De Risi;
 - c) The indebtedness of Viau towards its principal secured creditor, Loblaw's Inc., which holds a security on the inventory and equipment, was estimated as of today at approximately \$576,000;
 - d) The indebtedness of Viau towards its other creditors which might hold a security on the Property described above is to be determined;
 - e) The list of the other creditors of Viau is presented in Appendix A attached to the present notice;
 - f) The intended plan of action of the Receiver during the present receivership and where the Receiver considers it necessary can be described as follows (please note that such plan may vary from time to time depending on the circumstances):
 - To exercise control over the Property, wherever located, and to take any necessary measure in order to preserve, protect and safeguard it;
 - To make any payment of conservatory nature necessary to preserve the value of the Property;
 - To operate and manage the grocery store;
 - To retain the services of any lawyer, or of any person or business, in order to appropriately fulfill its functions;
 - To continue to engage the services of Viau's employees and/or hire employees, at the sole discretion of the Receiver, acting for and on behalf of Viau, until the Receiver terminates the employment;
 - Eventually, to establish a bidding process with respect to the enterprise and/or the assets of Viau;
 - To take any other necessary or appropriate measure or step in order to maximize the realization value of the enterprise of Viau, or of the Property, as the case may be.
