JUDGMENT

- [1] The Court is seized of a motion to extend the period for making a proposal dated November 19, 2014 (the "Motion").
- [2] Minéraux Maudore Itée ("Maudore") is a junior gold company with more than 22 exploration projects located in the district of Abitibi. Maudore is the majority shareholder of Mines Aurbec Inc. ("Aurbec"), a mining and mining exploration company whose

business activities relate to the exploration, development and operation of two gold mining sites (Sleeping Giant and Vezza), both located in the district of Abitibi.

- [3] On September 8, 2014, both Aurbec and Maudore filed notices of their intention to make a proposal to their créditors under the *Bankruptcy and Insolvency Act*¹("BIA") with Samson Bélair /Deloitte & Touche Inc. agreeing in both instances to act as proposal trustee ("Trustee"). Court orders have been made on October 8, 2014, extending the period for Aurbec and Maudore to make their proposals until November 21, 2014.
- [4] Today Maudore seeks an order to extend the time to file its Proposal to January 5, 2015. The motion was brought on short notice. Based on the affidavit of service filed, the Court is satisfied that notice was given to the interested parties.

- [11] **CONSIDERING** that the cash-flow statements were filed within 10 days after filing the notice of intention in accordance with subsection 50.4 (2) of the *Bankruptcy* and *Insolvency Act*;
