By Order of the Superior Court of Justice (Commercial List) of Ontario (the "**Court**") dated April 25, 2019 (the "**Appointment Order**"), Deloitte Restructuring Inc. ("**Deloitte**") was appointed as Receiver (the "**Receiver**") of all of the assets, undertaking and properties of BMT acquired for, or used in relation to a business carried on by the Debtors. We refer to our previous notices to factories dated April 26, 2019 and May 3, 2019, respectively.

Exclusive Agreement with Kellytoy Worldwide, Inc.

The Receiver is pleased to announce it has reached an exclusive agreement with Kellytoy Worldwide, Inc. ("Kellytoy") to facilitate the completion of BMT's current open orders and licence BMT's intellectual property and designs. No other plush supplier who may be purporting to act for and on behalf of BMT or the Receiver is authorized to deal with the current open orders.

Introducing Kellytoy Worldwide, Inc.

Kellytoy Worldwide, Inc. is one of the largest toy companies in the United States and is the creator and owner of the popular Squishmallow brand. Kellytoy is a global distributor that provides product to most of the major Mass Merchandisers, Supermarkets, Amusement Companies and Pharmacies in the US, Canada, Europe and Latin America. It is a family owned business founded in 1985 with offices in Los Angeles, New York, Hong Kong and Qingdao.

A representative of Kellytoy will be in contact with you in the coming week to facilitate the transition of your order and to confirm your order specifications, shipping windows and delivery requirements.

Amounts payable for orders which have already shipped

Both the Receiver and Kellytoy are not liable to pay past due amounts to factories for orders which have already shipped. Any amounts owing to factories for orders which have been shipped are stayed in accordance with paragraph 10 of the Appointment Order and cannot be paid by the Receiver. These

amounts form an unsecured claim against the insolvent estate of BMT and do not form part of the agreement between the Receiver and Kellytoy.
