 An Order validating and abridging service of this Notice of Application and the materials in respect thereof, including an Affidavit of Muir Barber sworn September 16, 2020 and a draft Order.

- 2. An Order extending the Amended and Restated Initial Order granted July 5, 2018 in these proceedings by the Honourable Mr. Justice N.G. Gabrielson (the "Initial Order") pursuant to the Companies' Creditors Arrangement Act, RSC 1985, c C-36 (the "CCAA"), as most recently amended by the Order of the Honourable Mr. Justice N.G. Gabrielson granted August 31, 2020 and the stay of proceedings provided therein until October ______, 2020.
- 1012977277 Saskatchewan Ltd. ("7277") also seeks an adjournment of the applications made by it in its Notice of Application dated November 4, 2019.
- 4. An Order permitting the engineering consultant selected by 7277, Dustin Weiss, access to and entry onto the property owned by Copper Sands Land Corp. and/or MDI Utility Corp. for the purposes of inspecting and reviewing the Water Utility and Waste Water Utility located thereon and all equipment, structures and accessories in respect thereof, such access to include any buildings, structures or other facilities in which the said Utilities are located. Such access is for the purposes of enabling the said engineer to better understand the nature and scope of the said Utilities.

Grounds for making this application:

- 5. It only became known to counsel for the parties to this CCAA Proceeding on September 15 that the presiding Judge had limited availability to deal with applications prior to the current expiration of the CCAA proceedings scheduled to expire on September 22, 2020 at 11:59 p.m.
- 6. The engineer reports and reviews ordered by this Court in its order granted April 1, 2020 are not yet completed. Efforts are underway to have those reports and reviews completed as quickly as possible, but it will take some additional time for those to be completed and provided to the Court.
- 7. 7277 has requested permission from the Monitor and/or the Applicants to allow 7277's engineer consultant access to the lands and premises upon which the Waste Water Utility and Water Utility are located. Such access is sought for the purposes of better understanding the nature, scope, extent and state of completion for the Waste Water Utility and the Water Utility and to have a more informed and better understanding and ability to comment on each of those Utilities. To date, the Applicants have not agreed that such access should be granted. The last position communicated by Jaimey Midtdal,

the principal of each of the Applicants was that she saw no need for such on-site investigation to occur.
