ORDER

(Extension of Stay of Proceedings)

Upon hearing Craig Frith, counsel on behalf of the Monitor, Deloitte Restructuring Inc., Rick Van Beselaere, Q.C., counsel on behalf of 101297277 Saskatchewan Ltd., Alexander Shalashniy, counsel on behalf of Industrial Properties Regina Limited, and upon reading the draft Order, all filed; and the pleadings and proceedings herein;

The Court orders:

1. The Amended and Restated Initial Order granted July 5, 2018 in these proceedings by the Honourable Mr. Justice N.G. Gabrielson, as most recently amended by the Order of the Honourable Mr. Justice G.M. Currie (granted September 23, 2020), and the stay of proceedings provided therein, shall be and is hereby further extended effective as of 11:59 p.m. on Friday, October 16, 2020 until 11:59 p.m., Saskatchewan time on Tuesday, October 27, 2020.
2. Paragraph 2 of the Order of this Court granted October 13, 2020 is hereby amended so as to authorize and direct MLT Aikins LLP to pay Catterall & Wright Consulting Engineers' invoice dated October 13, 2020 in the amount of \$44,961.97 from the

amount held in trust pursuant to previous Order of this Court dated March 12, 2019, with the balance of funds in the amount of \$179,695.92 to be paid into Court to this proceeding. The amounts paid into Court shall be dealt with by this Court upon application at a later date.
