- 1. **THIS COURT ORDERS** that the time for service of the Notice of Motion and the Motion Record is hereby abridged and validated so that this Motion is properly returnable today and hereby dispenses with further services thereof.
- 2. **THIS COURT ORDERS** that the stay of proceedings provided for in paragraph 9 of the Order of the Honourable Justice Dunphy dated July 30, 2018 (the "Receivership Order") in this proceeding be and hereby is lifted for the limited purpose of allowing Cooper to set down for trial the action commenced in the Cochrane Superior Court of Justice bearing Court File No. CV-18-00000165-0000 (the "Lien Action") in accordance with s.37(1) of the *Construction Act*, R.S.O. 1990, c. C.30, as it read on or before June 30, 2018.
- 3. **THIS COURT ORDERS** that a copy of this Order be filed in the court file for the Lien Action.
- 4. **THIS COURT ORDERS** that, apart from the relief in paragraph 2 of this Order, the Lien Action continues to be stayed in accordance with the Receivership Order.
- 5. **THIS COURT ORDERS** that the Lien Action not be set on any list for trial without further Order of this court.

6. **THIS COURT ORDERS** that a copy of this Order shall be sent to counsel for Deloitte Restructuring Inc., the Court-Appointed Receiver of all the assets, undertakings and properties of the Respondent, Sage Gold Inc., by e-mail forthwith after entry.

7. **THIS COURT FURTHER ORDERS** that nothing in this Order shall in any way prejudice the right of the Receiver, Sage Gold Inc. or any other party to take the position that the Lien Action was issued contrary to the stay of proceedings granted in the Receivership Order or that the lien claimed by Cooper is otherwise ineffective.
