#### **ENDORSEMENT OF JUSTICE CAVANAGH:**

- [1] The Applicant, Bank of Montreal, brings this application for a receivership order over the undertaking and personal property of Serendipity Media Ltd. and all of the assets, undertakings and properties of the guarantor entities (as identified in the application materials) (collectively, the "Debtors") acquired for, or used in relation to a business carried on by the Debtors.
- [2] The application is brought pursuant to section 243(1) of the *Bankruptcy and Insolvency Act* and section 101 of the *Courts of Justice Act* on the ground that it is just or convenient to appoint a receiver.
- [3] I have reviewed the application materials and heard submissions from counsel for the Applicant. The Debtors consent to the requested order. No one appeared to oppose.
- [4] I am satisfied that it is just and convenient for a receiver to be appointed. I accept the submissions made on behalf of the Applicant at paragraphs 12-22 of the Applicant's factum.
