## Notice to the creditors of Accel Canada Holdings GP Limited (the "Company")

Take notice that on October 24, 2019 (the "Filing Date"), Accel Canada Holdings GP Limited filed a Notice of Intention to Make a Proposal (the "NOI") pursuant to Section 50.4(1) of the Bankruptcy and Insolvency Act (the "BIA") and Deloitte Restructuring Inc. has been named as Trustee ("Deloitte" or the "Trustee") under the NOI. Accel Energy Canada Limited and Accel Canada Holdings Limited also filed separate NOIs on October 21, 2019.

Pursuant to Section 69(1) of the BIA, the effect of filing an NOI is an automatic stay of proceedings (the "Stay") against all creditors from continuing or commencing any actions against the Company. The Company has 30 days within which to file a Proposal to its creditors, or to seek an extension of the time from the Court of Queen's Bench of Alberta (the "Court") to file a Proposal.

Enclosed with this letter are the following documents for your records:

- A copy of the NOI;
- A list of known creditors with debts greater than \$250 as at the Filing Date;
- · A Certificate of Filing of a NOI issued by the Official Receiver; and
- The Consent of the Trustee.

Information related to the NOI proceedings will be posted on Deloitte's website at <a href="https://www.insolvencies.deloitte.ca">www.insolvencies.deloitte.ca</a> under the link entitled "Accel Canada Holdings Limited, Accel Canada Holdings GP Limited and Accel Energy Canada Limited".

The Trustee is required to monitor the Company's business and affairs during the Stay and to report any material adverse changes to the Office of the Superintendent of Bankruptcy and the Court.

If a Proposal is filed, the Trustee will issue further correspondence, including a copy of the Proposal, the Trustee's report on the proposal, a proof of claim form, a voting letter, a proxy and a notice to creditors regarding the First Meeting of Creditors. Until a Proposal is filed with the Official Receiver, it is not necessary for creditors to file Proof of Claim forms.
