ORDER

UPON THE APPLICATION of Deloitte Restructuring Inc. ("Deloitte") in its capacity as Court-Appointed Receiver of the property of Graham Brothers Construction Group Ltd. ("Graham Brothers"); AND UPON noting that Deloitte wishes to sell substantially all of the remaining assets and equipment of Graham Brothers as outlined in the attached Schedule "A" (the "Assets"); AND UPON being advised that Deloitte has approached three auction companies in respect of purchasing the Assets to be sold by way of public auction (the "Auction Proposals"); AND UPON being advised that Deloitte has received a further two offers from third party purchasers (the "Purchase Offers"); AND UPON being advised that it is Deloitte's opinion that the Purchase Offer received from Fourpoint Industrial Services Inc. ("Fourpoint") is superior to the Auction Proposals and the other Purchase Offer; AND UPON noting that the terms and



conditions of the offers received by Deloitte, particularly the amounts offered to purchase the Assets, are commercially sensitive and may affect the total amount recoverable from the sale of the Assets if disclosed prior to the conclusion of a sale; AND UPON reading the Ninth Report of the Receiver, and the Confidential Addendum thereto; AND UPON reading the Affidavit of Service of Notice of this Application; AND UPON hearing counsel for Deloitte; IT IS HEREBY ORDERED AND ADJUDGED THAT:

- Service of notice of this Application and supporting materials including, but not limited to, the Ninth Report of the Receiver in the manner described in the Affidavit of Service is hereby deemed good and sufficient and time for service is abridged as required.
- 2. Deloitte is hereby authorized to proceed with the sale of the Assets outlined in the attached Schedule "A" to Fourpoint in accordance with and for the price set forth in the Offer to Purchase attached as Appendix "E" to the Confidential Addendum of the Receiver's Ninth Report, and the sale of the Assets to Fourpoint is hereby approved with such minor amendments as Deloitte may deem necessary.
- Deloitte is hereby authorized and directed to take such additional steps and execute such additional documents as may be necessary or desirable for the completion of the sale of the Assets.
- 4. Deloitte shall receive and retain the proceeds from the sale of the Assets for the benefit of the creditors of Graham Brothers and shall not disburse the same except in accordance with the Orders granted in this Action or on further Order of the Court.
- 5. The Ninth Report of the Receiver is hereby accepted and approved by this Honourable Court.
- 6. The Confidential Addendum to the Ninth Report of the Receiver is hereby accepted and approved, and shall remain unfiled until such a time as the sale of the Assets has concluded, at which time Deloitte shall file and serve the same.
