This Application is being made by Deloitte Restructuring Inc. in its capacity as the Courtappointed Receiver of certain of the UBG Group of Companies, and in accordance with its ancillary powers as the former Monitor of the UBG Group of Companies.

REMEDIES CLAIMED OR SOUGHT

- 1. Deloitte Restructuring Inc. ("**Deloitte**"), in its capacity as the Court-appointed receiver and manager (the "**Receiver**") of certain of the UBG Group of Companies, and in accordance with its ancillary powers (post-discharge) as Monitor of the UBG Group of Companies, seeks the following Orders:
 - (a) An Order deeming service good and sufficient;
 - (b) An Order substantially in the form attached as **Schedule "1"**:
 - (i) approving the Receiver's / former Monitor's disallowance of a claim made by the unsecured creditor Steve Ulsifer ("**Disallowance Order**");

- (c) An Order substantially in the form attached as **Schedule "2"**:
 - (i) approving the Receiver's statement of receipts and disbursements as set out in the Fifth Report of the Receiver, to be filed ("Fifth Report");
 - (ii) approving the actions of the Receiver as reported in the Fifth Report;
 - (iii) approving the professional fees of the Receiver and its legal counsel, Bennett Jones LLP, as summarized in the Fifth Report;
 - (iv) approving the interim distribution of funds to the creditors of the UBG Group of Companies as set out in the Fifth Report; and
 - (v) such further and other relief as counsel may advise and this Court deems just;

(collectively, the "Interim Distribution Order").

GROUNDS FOR MAKING THIS APPLICATION

Background

- 2. On May 9, 2012, the Court of King's Bench ("Court") issued an Order ("Initial Order") granting the UBG Group of Companies protection pursuant to the *Companies Creditors Arrangement Act* ("CCAA Proceedings"). Ernst & Young Inc. ("EY") was appointed monitor (the "Monitor") under the Initial Order.
- 3. On June 15, 2012, the Court issued an Order that established a claims procedure in which affected creditors could file a proof of claim ("Claim Procedure Order"). The Claim Procedure Order gave the Monitor the power to accept, revise, or reject the proof of claim.
- 4. On August 10, 2016, the Court issued an Order substituting Deloitte as Monitor in place of EY.

- 5. On December 12, 2017, Deloitte was appointed as receiver and manager of the property, undertakings and assets of certain of the UBG Group of Companies, who were unable to proceed with plans of Compromise and Arrangement in the CCAA Proceedings ("Receivership Order").
- 6. On August 17, 2022, the Court granted an Order in the CCAA Proceedings discharging the Monitor and terminating the CCAA Proceedings, along with other relief ("**Discharge Order**"). The Discharge Order states that "Deloitte shall remain the Monitor for the performance of such incidental duties as may be required to complete the administration of the receivership herein."

The Disallowance Order

- 7. The Receiver understands that Steve Ulsifer is a former employee of UBG Builders Inc., one of the entities included in the UBG Group of Companies. Pursuant to the process laid out in the Claim Procedure Order, Mr. Ulsifer returned a completed proof of claim to the Monitor on July 26, 2012. Mr. Ulsifer claimed that he was owed working notice pay and severance pay totaling \$71,942.31 in connection with his termination from UBG Builders Inc.
- 8. On May 29, 2023, via letter, Deloitte, in its capacity as both Receiver and in accordance with its ancillary powers as discharged Monitor, wrote to Mr. Ulsifer and notified him it had disallowed his claim because it had insufficient documentation to verify his claim ("Notice of Disallowance").
- 9. On June 15, 2023, Mr. Ulsifer delivered the Dispute Notice to Deloitte via facsimile. The Dispute Notice provided no new or additional documentation and simply restated what was in Mr. Ulsifer's proof of claim.
- 10. Deloitte, in its capacity as Receiver and in accordance with its ancillary powers as Monitor pursuant to the Discharge Order, seeks an Order of this Court approving its decision to disallow Mr. Ulsifer's claim because there is insufficient documentation to prove the claim.

Activities of the Receiver

11. As set out in the Fifth Report, the Receiver has:

- (a) collected substantially all outstanding accounts receivable of those of the UBG Group of Companies in receivership, except where the Receiver has determined that such amounts are uncollectible;
- (b) realized on the assets, undertakings and property of those of the UBG Group of Companies in receivership;
- (c) corresponded with various creditors, employees, and other interested parties with respect to the receivership proceedings;
- (d) addressed post-receivership Goods and Services Tax ("GST") filings;
- (e) corresponded with various joint venturers;
- (f) completed a detailed review of claims filed against UBG Inc. and issued Notices of Revision or Disallowance ("NORs");
- (g) completed a review of claims filed against Tuscany Development (2006) Inc. and Tuscany Development LP (collectively "**Tuscany**");
- (h) corresponded with Bennett Jones, the Receiver's independent legal counsel on various legal matter relating to the receivership;
- (i) responded to various inquiries from creditors and other stakeholders as appropriate;
- (j) attended to matters of both general and specific nature required over the course of the receivership proceedings not referred to above; and
- (k) prepared, reviewed and finalized the Fifth Report.

Approval of Distributions

12. The Receiver completed its review of the 52 claims filed against UBG Builders Inc. totaling \$403,037,421. 26 claims totaling \$394,398,7112 were disallowed including:

- (a) Six (6) claims totaling \$341,729,709 were filed against multiple entities within the UBG Group of Companies and were previously disallowed in 2015 and in 2022 through the claims processes in relation to the other entities within the UBG Group of Companies, which disallowances were approved by this Court;
- (b) On May 29, 2023, Deloitte disallowed twenty (20) additional claims totaling \$52,669,003, and received one (1) dispute notice from Mr. Ulsifer, a former employee of UBG. Based on Deloitte's review of the dispute notice, and as set out above, the claim of Mr. Ulsifer should remain disallowed.
- 13. The Receiver will hold approximately \$4.6 million for distribution to the proven UBG Inc. creditors. The Receiver proposes to hold back approximately \$300,000 from the distribution on account of various expenses that will be incurred in connection with the interim distribution and continuing the administration of the UBG Inc. receivership estate including professional fees and costs.

Approval of the Actions of the Receiver

14. In the Fifth Report, the Receiver has set out a description of the activities undertaken by the Receiver since the date of the Fourth Report of the Receiver dated January 30, 2023 (the "Fourth Report").

Approval of the Receipts and Disbursements of the Receiver

15. In the Fifth Report, the Receiver has set out a description of its receipts and disbursements since the date of the Fourth Report.

Approval of the Professional Fees of the Receiver and its Counsel

16. In the Fifth Report, the Receiver has set out a summary of its professional fees and those of its legal counsel since the date of the Fourth Report.

- 17. The pleadings and proceedings had and taken in this Action, including the Fifth Report.
