**Notice to depositors of the Lutheran Church – Canada, the Alberta – British Columbia District Investments Ltd. (“District Investments” or “DIL”) who hold Registered Retirement Income Funds (“RRIF(s)”) or Locked-in Income Funds (“LIF(s)”)**

---

As you are aware, the District obtained an Initial Order under the *Companies’ Creditors Arrangement Act*, R.S.C. 1985 c. C-36, as amended (the “CCAA”) on January 23, 2015. Deloitte Restructuring Inc. acts as the Monitor in the CCAA proceedings (the “Monitor”).

Further to prior correspondence from the Monitor, on August 28, 2015, the Court of Queen’s Bench of Alberta granted an Order (the “August 28 Order”) approving an interim distribution for up to \$15.0 million (the “DIL Distribution”) from DIL’s registered retirement savings plans to new registered retirement savings plans held by Great-West Life Assurance Company (“GWL”). On November 5, 2015, the Court granted a subsequent Order amending the August 28 Order such that DIL Depositors who held RRIFs and LIFs could transfer the amounts payable to them pursuant to the DIL Distribution to an alternate registered account of their choosing.

District Investments’ records indicate that DIL has not yet received a request to transfer the amount payable to you pursuant to the DIL Distribution to an alternate registered account. We request that you contact your financial institution or other investment advisor at your earliest convenience to have your transfer documents completed and forwarded to DIL for processing.

**What you need to do:**

Contact your financial institution or other investment advisor to have them request a transfer from DIL to another RRIF or LIF.
