INTRODUCTION

- Pursuant to an Order (the "Receivership Order") of the Court of Queen's Bench of Alberta (the "Court") dated March 21, 2017 (the "Date of Receivership"), Deloitte Restructuring Inc. ("Deloitte") was appointed as receiver and manager (the "Receiver"), without security, of all assets, undertakings and properties of Gabriel Construction Ltd. ("GCL"), Gabriel Construction (Alberta) Ltd. ("GCAL") and SaskAlta Environmental Solutions Inc. ("Saskalta") (collectively, the "Companies" or the "Group"). The Court proceedings in which the Receiver was appointed are referred to herein as the "Receivership Proceedings".
- The Receivership Order was granted as a result of an application by Royal Bank of Canada ("RBC") which was owed approximately \$2.6 million by the Group at the Date of Receivership (the "RBC Indebtedness"). RBC holds various registered security over all of the Group's present and after-acquired real and personal property, along with various personal guarantees (collectively, the "RBC Security"). The loans provided by RBC to GCL, GCAL and Saskalta were cross guaranteed and cross collateralized by each of the Companies.
- The Receiver's independent legal counsel, Torys LLP ("**Torys**"), has conducted an independent review of the validity and enforceability of the RBC Security and has advised that it is valid and enforceable and ranks in priority to the unsecured creditors of the Group and to any subsequently appointed trustee in bankruptcy (the "**Security Opinion**").
- Following the issuance of the Receivership Order, the Receiver issued a statutory 4) Notice and Statement of the Receiver for each of GCL, GCAL and Saskalta (the "Notices to Creditors") pursuant to subsections 245(1) and 246(1) of the Bankruptcy and Insolvency Act (Canada). The Receivership Order, together with the Notices to Creditors have been posted on the Receiver's website http://www.insolvencies.deloitte.ca/en-ca/Pages/Gabriel "Receiver's (the Website"). This first report of the Receiver (the "First Report") will also be posted to the Receiver's Website after it has been filed with the Court.
- 5) In addition to the First Report, the Receiver has prepared a confidential supplement to the First Report dated June 1, 2017 (the "First Confidential Report") which the Receiver is seeking to be sealed in the Court file.
- 6) Unless otherwise provided, all other capitalized terms not defined in this First Report are as defined in the Receivership Order.

Purpose

- 7) The purpose of this First Report is to:
 - a) Provide the Court with an update of the Receiver's activities and the Receiver's receipts and disbursements since the Date of Receivership; and
 - b) Respectfully recommend that the Court:
 - i. Approve the reported activities of the Receiver to date in respect of administering the Receivership Proceedings;
 - ii. Approve the Maynards Proposal for the sale of the Equipment (terms as defined later in this First Report);

- iii. Approve the future distribution of funds to RBC as they relate to the RBC Security and as they become available up to the amount of the RBC Indebtedness, and subject to the Receiver holding sufficient funds to satisfy the costs of the Receivership Proceedings, and statutory deemed trust and priority claims; and
- iv. Approve an Order sealing the First Confidential Report in the Court file.

Terms of Reference

- In preparing this First Report, the Receiver has relied upon unaudited financial and other information prepared by the Group's current and former employees, the Group's books and records, and discussions with the Group's former employees and various third parties with knowledge of the Companies and their assets and operations. The Receiver has not audited, reviewed or otherwise attempted to verify the accuracy or completeness of the information in a manner that would wholly or partially comply with Generally Accepted Assurance Standards pursuant to the *Chartered Professional Accountants Canada Handbook* and, accordingly, the Receiver expresses no opinion or other form of assurance in respect of this information.
- 9) All dollar amounts in this First Report are in Canadian dollars, unless otherwise indicated.

BACKGROUND

- 10) GCL is a private company that is incorporated in the Province of Saskatchewan ("SK"). GCL operated as a construction general contracting company, specializing in commercial, industrial and institutional construction projects in SK.
- GCL is majority owned by the former principal of the Group, Mr. Gabriel Grenier ("Mr. Grenier") who holds approximately 86% of the voting shares and GCL in turn owns 100% of GCAL and Saskalta.
- 12) GCL operated from premises owned by GCL that are located at 234-11th Avenue East, in SK (the "**Regina Property**").
- GCAL is a private company that is incorporated in the Province of Alberta ("AB"). GCAL operated as a construction general contracting company, specializing in commercial, industrial and institutional construction projects in AB.
- GCAL operated from a property owned by Mr. Grenier, which is located in a rural area close to Cremona, AB (the "Cremona Property").
- 15) Saskalta is a private company that is incorporated in AB. Saskalta specialized in the management of industrial, commercial and municipal hazardous and non-hazardous waste, and primarily provided dredging, pumping, desludging and dewatering services.
- 16) Saskalta operated from the Cremona Property and shared employees with GCAL.
- 17) Mr. Grenier is the sole director of GCAL and is a joint director of GCL with Ms. Sonia Grenier. The corporate search for Saskalta did not provide any director information.

- As a result of declining revenues and financial losses incurred by GCAL and Saskalta, the Group began to experience financial difficulties in early 2016. Despite attempts to rationalize the business and liquidate some of the Group's equipment in order to improve liquidity, the Group continued to experience cash flow difficulties. Ultimately, this culminated in Mr. Grenier's decision to cease operations of the Group and to terminate all of the Group's employees on March 10, 2017.
- 19) RBC, the principal and first ranking secured creditor of the Group, was concerned about the status of the Group's equipment and ongoing construction contracts. As a result, RBC took steps to have a Receiver immediately appointed over the Group.

POWERS OF THE RECEIVER

The Receiver's powers are detailed in paragraph 3 of the Receivership Order and include, among others, the power to take and maintain possession and control of the assets of the Group; the power to manage, operate and carry on the business of the Group; and, the power to market and sell the assets of the Companies (subject to Court approval if any one transaction exceeds \$100,000 or if the aggregate of transactions exceed \$200,000).

POSSESSION AND CONTROL OF THE ASSETS

- The Receiver took the following steps with respect to the assets and operations of the Group:
 - a) Attended the Cremona Property and Regina Property (collectively, the "Operating Properties") and met with several former employees of the Group who had been winding up the business;
 - b) Took possession of the Group's books and records at the Operating Properties;
 - c) Carried out an inspection and took an inventory of the Group's assets and equipment located at the Operating Properties;
 - d) Attended at and took an inventory of the Group's assets and equipment at various project sites and storage facilities in both AB and SK;
 - e) Arranged for an appraisal of the Group's assets;
 - f) Arranged to have all utility accounts for the Operating Properties transferred to the name of the Receiver;
 - g) Retained five of the Group's former employees (the "Subcontractors") to assist with the collection of information relating to the Group's employees, the location of assets, the Group's unfinished construction projects, and those contracts with outstanding accounts receivable owing to the Group;
 - h) Carried out a detailed review of the Group's unfinished construction contracts and those with outstanding accounts receivable (collectively, the "**Unfinished Contracts**") in order to establish the status of the Unfinished Contracts, the cost to complete, and the ability of the Receiver to recover monies owing under

- the Unfinished Contracts. Further details around the Unfinished Contracts are included later in this First Report;
- Worked with the Subcontractors to arrange for the removal and relocation of the Group's most valuable assets and equipment from various project sites to the Operating Properties in order to preserve and protect the assets;
- j) Liaised with multiple asset finance companies to obtain buy-out quotes, and to assess the level of equity in financed equipment. Where there was determined to be no equity in the financed equipment, the Receiver wrote to the relevant finance companies to release its respective interest in the equipment;
- Advised the Companies' insurance broker of the receivership and confirmed and arranged for amendments to the existing insurance policies to reflect the Receivership Proceedings;
- Arranged for the redirection of the Group's mail to the Receiver's office;
- m) Liaised with various creditors, subcontractors and bonding companies relating to the Group's outstanding liabilities and the Unfinished Contracts; and
- n) Contacted CRA to request trust audits and to open a new GST account to facilitate GST filings for the period subsequent to the Date of Receivership.

ASSETS

Regina Property

- 22) The Regina Property was constructed in 1960 and incorporates approximately 4,811 sq. ft. of office/warehouse space, in addition to a large gated and fenced yard.
- 23) On April 20, 2017, the Receiver sent a request for proposal to four realtors in the Regina area seeking listing proposals for the Regina Property. A deadline for submission of proposals was set for May 5, 2017.
- Listing proposals were received from two realtors. Both realtors suggested a similar listing price, and had the same commission rate (5% of sale price). Based on the Receiver's assessment of the proposals, and in further discussion with RBC, the Receiver appointed Colliers International as the listing broker ("Colliers") on May 15, 2017.
- Colliers is now actively marketing the Regina Property and details are posted on Colliers' website. Any offers received on the Regina Property will be subject to Court approval.

Unfinished Contracts

- Prior to the Group ceasing to operate on March 10, 2017, the Group was engaged on several bonded and non-bonded construction contracts in SK and AB. As a result of the abrupt closure of the business, several of these contracts were partly finished.
- 27) The Receiver has reviewed various books and records, reports, contracts, invoices and correspondence related to the Unfinished Contracts. The Receiver also entered into

discussions with multiple owners of the projects, in addition to bonding companies, Mr. Grenier and the Subcontractors in order to assess the status of the projects and the best method to realize value from the Unfinished Contracts, to the extent possible. In total, the Receiver reviewed forty seven (47) Unfinished Contracts.

- Several of the Unfinished Contracts had significant arrears owing by the Group to subcontractors used on the projects and consequently multiple liens had been filed against these projects. As a result, many of the Unfinished Contracts were uneconomic to complete and, where applicable, the Receiver consented to allowing the bonding companies to take over the completion of the projects and to deal with the liens pursuant to the labour and material bonds. The Receiver monitored and will continue to monitor these projects and expects to receive appropriate reporting from the bonding companies in respect of any potential profits.
- The Receiver engaged Trans Canada Contracting Inc. ("**Trans Canada**") to complete a project in SK which was bonded by Echelon Insurance Company (the "**Surety**"). Following the completion of the project, the Receiver recovered proceeds under the contract in the amount of \$50,730. These monies are currently held in a separate trust account pursuant to the provisions of paragraph 32 of the Receivership Order, pending the receipt by the Surety of the original bonds from the owner of the project.
- 30) To date, the Receiver has entered into settlement discussions and agreements related to outstanding accounts receivable and deficiency claims on nine (9) different projects.
- 31) As at the Date of the Receivership, the Group had accounts receivable of approximately \$2.39 million and holdbacks receivable of approximately \$0.65 million. To date, the Receiver has realized approximately \$144,000 in accounts receivable and further realizations will be contingent on the amount of liens filed, ongoing negotiations and potential profits in respect of the Unfinished Contracts.

Contech Monies

- 32) The Receiver is aware of an amount of \$98,007 ("Lien Monies") having been paid into Court in order that a lien registered by Contech Electric Ltd. (the "Lien Claimant") be removed from title to certain lands where GCAL was undertaking a construction project.
- The Receiver has reviewed this matter with Torys and, based on the *Builders' Lien Act*, the Consent Order entered into between the parties, and correspondence between counsel for the parties, Torys has advised the Receiver that it likely has the right to the Lien Monies.
- Accordingly, on May 26, 2017, the Receiver filed an application with the Court to have the Lien Monies released from the Court to the Receiver, for the benefit of the Receivership estate. This matter is due to be heard by the Court on June 14, 2017.

Construction Equipment

- 35) The Group owned a significant amount of construction related equipment which was primarily located at the Operating Properties, and was also located at several job sites and storage facilities in AB and SK.
- The Receiver spent a significant amount of time reviewing the Group's asset register and attempting to reconcile it to the inventory of assets at each location, the insurance

records, personal property registry searches, lease agreements, auction sales and other records of the Companies. The Receiver also made enquiries of the Subcontractors and Mr. Grenier in order to ascertain the location of various missing items. In most cases, it was apparent that items had been sold in previous auctions undertaken in 2015 and 2016, and the asset register had not been updated to reflect all of the equipment sold in those auctions.

- After formulating an updated asset register, by location, the Receiver then engaged Century Services Corp. ("Century") to view the Group's construction related equipment/inventory and office furniture/equipment (collectively, the "Equipment"), and to undertake an appraisal of the Equipment (the "Century Appraisal"). A copy of the Century Appraisal is attached to the First Confidential Report as Appendix "A".
- In respect of a project site in northwestern AB, the Receiver entered into a short-term rental of the Group's equipment to enable the Surety to complete an urgent phase of construction related to the contract. The Receiver realized \$28,571 in respect of this rental agreement.

Foreign Investment

- The unaudited October 2016 financial statements of GCAL show an investment on the balance sheet in the amount of \$2.08 million (the "Foreign Investment"). According to a note in the financial statements, the Foreign Investment consists of advances made to a foreign company related to the Group, and in particular to GCAL, by virtue of common ownership. In addition, the notes state that the advances are unsecured, non-interest bearing and without fixed terms of repayment.
- The Receiver has discussed the Foreign Investment with Mr. Grenier. Based on these discussions, the Receiver understands that monies were advanced without any formal written agreements over several years from GCAL to a company incorporated in the Republic of Honduras for the purposes of developing a resort property in Camps Bay, on the island of Roatan, Honduras (the "Roatan Property").
- The name and ownership of the Honduran company that was advanced funds by GCAL is not clear. However, further searches undertaken by Torys indicate that it is likely to be Constucciones Gabriel S.A. ("Gabriel S.A."), which is a closely held private company whose controlling shareholder, Mr. Grenier, is the President of the Board. Based on investigations made by Torys, it is apparent that Gabriel S.A. owns the Roatan Property.
- 42) Mr. Grenier has informed the Receiver that monies advanced by GCAL were used to construct a 5,000 sq. ft. beachfront villa, and to develop various infrastructure (primarily roads and utilities) on the Roatan Property. The Receiver also understands that the original purpose of the Foreign Investment was to develop a residential resort community, with several homes located on the Roatan Property. However, the development of the resort has been delayed, in part due to waiting for an appropriate permit from the relevant authorities.
- The Receiver is aware that the Roatan Property was listed for sale with Re/Max in June 2016 for US\$1.15 million, but it failed to sell. Mr. Grenier has also stated that there is a mortgage on the Roatan Property that is held by a Honduran bank but the Receiver has not been provided any supporting documents.

The Receiver is continuing its investigations into Gabriel S.A. and the Roatan Property in order to consider the best method to realize value from the Foreign Investment, to the extent possible, for the benefit of creditors.

EQUIPMENT SALES PROCESS

Auction Process

- The Receiver engaged in discussions with RBC with respect to a proposed process to sell the Equipment. Based on the nature and location of the Equipment, the various leases in place and the difficulty in reconciling the Equipment listing, it was determined that proposals should be sought from auctioneers for the sale of the Equipment as well as from various parties that had expressed interest in the Equipment.
- As part of the sales process, the Receiver compiled available information in relation to the Equipment (the "Equipment Information Summary") which is attached as Appendix "A" to this First Report, and includes the following:
 - a) A listing and description of the Equipment by location;
 - b) A description of the locations where the Equipment was located; and
 - c) A link to access photos of the Equipment.
- 47) The Receiver emailed the Equipment Information Summary on May 15, 2017 to five (5) auctioneers, requesting proposals under the following terms and conditions:
 - a) Auctioneers were to demonstrate recent experience selling comparable types of equipment and were to be able to market the Equipment to a wide network of buyers;
 - b) The Equipment was to be offered for sale on an 'as-is, where-is' basis with no representations or warranties from the Receiver;
 - c) Given the nature of the Equipment, expected changes in the assets included in the listing, and in the interest of expediting the process, auctioneers were to submit a straight commission proposal for auction services. The Receiver did not seek proposals for any net minimum guarantees;
 - d) The Receiver would not be obligated to accept any proposal and the acceptance by the Receiver of any proposal would be subject to the approval of the Court;
 - e) Asset viewings would be coordinated with the Receiver; and
 - f) Proposals and offers were to be submitted by May 26, 2017 (the **"Submission Deadline**").
- 48) At the Submission Deadline, the Receiver received four (4) proposals from auctioneers to sell the Equipment on behalf of the Receiver.
- 49) The Receiver also sent the Equipment Information Summary, or extracts thereof, to three (3) third parties that had expressed an interest in making enbloc offers for the Equipment or offers for a significant amount of the Equipment. However, the offers

- received were for significantly less than the values included in the Century Appraisal, and therefore the Receiver did not accept the offers.
- The Receiver has discussed and shared the proposals received through the sales process with RBC, and RBC is in agreement with accepting the auction proposal from Maynards Industries Canada Ltd. ("Maynards") to sell the Equipment (the "Maynards Proposal").
- 51) The Maynards Proposal and reasons for its acceptance, are more fully described in the First Confidential Report, along with the other proposals received.
- 52) The Receiver has obtained quotes for the haulage of the equipment which remains at project sites and storage facilities back to the Operating Properties or to an alternate site, and intends to move this equipment when road conditions allow, and ahead of the auction sales, in collaboration with the auction company selected.

Asset Sale to Trans Canada

- The Receiver also received several offers from Trans Canada, including an offer in respect of equipment located at two (2) project sites in Wascana and Assiniboia, SK from Trans Canada. After subsequent negotiations and receipt of an improved offer from Trans Canada, the Receiver entered into a sale agreement with Trans Canada for the sale of certain equipment in the amount of \$16,000 plus applicable taxes (the "Purchase Price"). The Receiver notes that the Purchase Price was within the appraised value range provided by Century when accounting for the costs of hauling the equipment and additional storage costs which would be avoided by entering into the sale agreement with Trans Canada.
- 54) The sale agreement completed on May 25, 2017 and the Receiver is in receipt of payment of the Purchase Price.

CREDITORS AND SECURED CHARGES

- The RBC security is subject to certain prior ranking Court-ordered charges and statutory interests, which include:
 - a) the Receiver's Charge (as that term is defined in the Receivership Order);
 - the Receiver's Borrowing Charge (as that term is defined in the Receivership Order);
 and
 - c) certain deemed trust and priority claims as described in paragraphs 58 and 59 below.
- Pursuant to paragraph 17 of the Receivership Order, the Receiver and Torys as its legal counsel are the beneficiaries of the Receiver's charge, which is a first-ranking charge over the Property to secure payment of their fees and disbursements incurred in the Receivership Proceedings.
- Pursuant to paragraph 20 of the Receivership Order, the Receiver is authorized to borrow up to \$100,000 without further approval of the Court for the purpose of carrying out its duties and powers (the "Borrowing Facility"). As at the date of this First Report, the Receiver has accessed \$100,000 of the Borrowing Facility.
- 58) The Group's records indicate debts owing to Canada Revenue Agency ("CRA") in relation to payroll source deductions in the amount of \$24,658, and in relation to goods and

- services tax ("GST") in the amount of \$16,185 (collectively, the "CRA Deemed Trust Claims"). However, CRA has not yet conducted a payroll and GST trust audit on the Group as at the date of the First Report and additional liabilities may be assessed.
- The Receiver is also aware of potential priority claims in respect of the *Wage Earner Protection Program Act (Canada)* ("WEPPA") as there are outstanding RRSP remittances in the amount of \$1,283 and outstanding wages owing to former employees in the amount of \$11,030 (collectively, the "Priority Claims"). The Receiver sent the appropriate WEPPA notices to the Group's former employees, and the prescribed information to the Minister of Labour for twenty nine (29) employees that were owed eligible wages. The maximum priority claim that may rank in front of RBC for WEPPA claims is \$2,000 per employee but this generally only applies to wages and vacation pay.
- As noted previously, RBC is the principal secured creditor of the Companies, was owed approximately \$2.6 million at the Date of Receivership, and has a valid and enforceable security (as reported in the Security Opinion). Based on the Security Opinion, the Receiver is seeking approval from the Court to approve the future distribution of funds realized by the Receiver to RBC, as they relate to the RBC Security and as they become available, up to the amount of the RBC Indebtedness, and subject to the Receiver maintaining sufficient funds to satisfy the costs of the Receivership Proceedings, including, amongst other things, payment of the Receiver's fees and disbursements, Torys' fees and disbursements, the CRA Deemed Trust Claims and the Priority Claims (once properly proven and admitted by the Receiver).
- As at the Date of Receivership, the available books and records of the Companies reported unsecured creditors with claims of approximately \$3.24 million.
- filed against GCAL and ISL Engineering and Land Services Ltd. by the Town of Westlock and Westlock Regional Water Services Commission (the "ToW Action"). The plaintiffs in the ToW Action are suing for breach of contract and negligence. The ToW Action is seeking damages of \$1.63 million plus costs. The Receiver has not yet reviewed the facts or merits of the ToW Action and has not received a legal opinion regarding the validity or quantum of any potential claim. However, the Receiver has consented to the Receivership Order being lifted in respect of the ToW Action subject to the provisions of the Consent Order dated May 23, 2017.

STATEMENT OF RECEIPTS AND DISBURSEMENTS

- 63) Attached as Appendix "**B**" to this First Report is a Statement of Receipts and Disbursements reflecting the administration of the Receivership Proceedings for the period from the Date of Receivership to May 30, 2017.
- As at May 30, 2017, the Receiver's gross receipts, excluding the draws on the Borrowing Facility, amounted to approximately \$193,500 and the Receiver held approximately \$228,000 in trust (including monies drawn on the Borrowing Facility).
- During the same period, the Receiver has made disbursements, excluding transfers of monies under the Borrowing Facility, totalling \$65,000, including, amongst other items, insurance premiums, Subcontractor fees and utilities.
- The Receiver notes that included in the disbursements made to date are payments made to three (3) former employees of GCL based in SK. These payments amount to \$7,466 and relate to unpaid wages and expenses incurred after the Group ceased

operations on March 10 and prior to the Date of Receivership. During this period, the Receiver understands that these employees worked on securing assets of the Group and updating various contract and financial information. The Receiver believes that the payment of these costs are justified as these expenditures were primarily associated with preserving and protecting assets of the Group, and were necessary in order to secure the ongoing cooperation of the employees to assist the Receiver in carrying out its powers and duties.

The Receiver has invoiced approximately \$116,000 in fees and costs (before taxes) to April 28, 2017 and Torys has invoiced fees and costs (before taxes) of approximately \$50,000 to April 30, 2017. No professional fees have been paid to date due to the limited funds currently being held in the Receiver's trust accounts.

CONCLUSIONS AND RECOMMENDATIONS

- 68) Based on the foregoing, the Receiver respectfully requests that the Court:
 - j. Approve the reported actions of the Receiver to date in respect of administering the Receivership Proceedings;
 - ii. Approve the Maynards Proposal for the sale of the Equipment;
 - iii.
