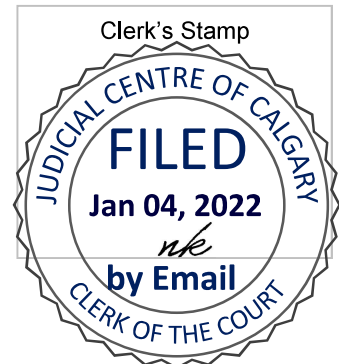

- A. Pursuant to the Order of this Honourable Court dated January 23, 2015 (the "**Initial Order**") the Applicants filed for and obtained protection from creditors under the *Companies' Creditors Arrangement Act*, R.S.C. 1985, c. C-36, as amended.
- B. Pursuant to the Initial Order, Deloitte Restructuring Inc. was appointed as the Monitor of the Applicants (the "**Monitor**") with the powers, duties and obligation set out in the Initial Order, as amended from time to time.

- C. Pursuant to the Order of this Honourable Court dated May 19, 2015, Kluane Financial Services Inc. was appointed Chief Restructuring Officer of the Applicants with the powers, duties and obligations set out in that Order and in the Order of this Honourable Court dated March 6, 2015, as amended from time to time.
- D. On January 11, 2016, DIL filed an Amended Amended Plan of Compromise and Arrangement under the CCAA dated January 11, 2016 (the “**DIL Plan**”), which has been sanctioned pursuant to an Order of this Honourable Court, filed August 5, 2016.
- E. Unless otherwise indicated herein, initially capitalized terms used herein have the meaning set out in the DIL Plan
