


UPON the Application of Gamet Resources Ltd. ("**Gamet**"); AND UPON reading the Affidavit of Garry Moyes sworn April 11, 2016, the Second Affidavit of Garry Moyes sworn May 26, 2016, the Third Affidavit of Garry Moyes sworn July 7, 2016, and the Affidavit of Natalie Birtwistle sworn July 12, 2016; AND UPON reading the First Report of the Proposal Trustee, Ernst & Young Inc. (the "**Proposal Trustee**") dated April 13, 2016, filed, the Second Report of the Proposal Trustee dated May 26, 2016, filed, and the Third Report of the Proposal

Trustee dated July 7, 2016, filed; AND UPON noting that Gamet filed a Notice of Intention to make a Proposal with the Official Receiver pursuant to section 50.4(1) of the *Bankruptcy and Insolvency Act*, RSA 1985, c B-3, as amended ("*BIA*") on March 18, 2016; AND UPON noting Gamet's exclusive financial advisor, Sayer Energy Advisors ("*Sayer*"), ran a marketing process (the "*Marketing Process*") for Gamet's assets and that a winning bid was accepted for the *en bloc* purchase of all of Gamet's assets; AND UPON noting that the winning bidder is in the process of completing its due diligence and has advised that it intends to structure the purchase of Gamet's assets as a corporate acquisition, rather than an asset purchase; AND UPON being satisfied that:

- (a) Gamet has acted, and is acting, in good faith and with due diligence;
- (b) Gamet would likely be able to make a viable Proposal if the extensions being applied for are granted; and
- (c) no creditor will be materially prejudiced if the extensions being applied for are granted;

IT IS HEREBY ORDERED THAT:

1. Service of notice of this application and supporting materials is hereby declared to be good and sufficient, and no other person is required to have been served with notice of this application, and time for service of this application is abridged to that actually given.
2. The period in which Gamet may file its Proposal herein and the stay of proceedings currently in place are hereby extended to September 1, 2016.
3. Gamet shall notify all known creditors of this extension by posting this Order on the Proposal Trustee's website.
4. There shall be no costs of this Application.
