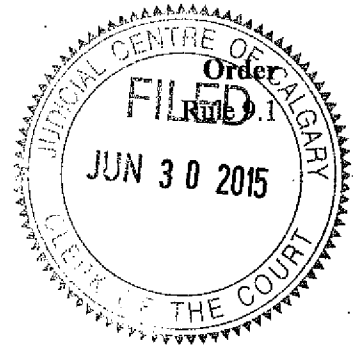


NAME OF JUSTICE WHO MADE THIS ORDER: Honourable Madam Justice J. Streckaf

UPON THE APPLICATION of counsel for Deloitte Restructuring Inc., in its capacity as court-appointed receiver and manager (the “**Receiver**”) of the undertaking, property and assets of Big Eagle Hydro-Vac Inc., Big Eagle Limited Partnership, Big Eagle Hydro-Vac (North) Inc., and Big Eagle (North) Limited Partnership (collectively, the “**Debtors**”) for an order sealing the

Auction Services Agreement between the Receiver and Great American Global Partners LLC, dated June 25, 2015 (the "Stalking Horse Bid") containing un-redacted Schedule 1.1(8); **AND UPON HEARING** counsel for the Receiver, counsel for WellsFargo Foothill Canada ULC and counsel for Great American Global Partners LLC ("GA"); **AND UPON HAVING READ** the First Report of the Receiver filed June 26, 2015; **AND UPON HAVING READ** the application for approval of auction and asset solicitation procedures, filed June 26, 2015;

IT IS HEREBY ORDERED THAT:

1. Division 4 of Part 6 of the Alberta Rules of Court does not apply to this Application.
2. The Stalking Horse Bid containing an un-redacted "Schedule 1.1(8) – Assets" shall, until further Order of the Court, be kept sealed and kept confidential, to be shown only to a Justice of the Court of Queen's Bench of Alberta, and accordingly, shall be filed with the Clerk of the Court who shall keep the Second Confidential Supplement in a sealed envelope, which shall clearly be marked "SEALED PURSUANT TO THE ORDER OF THE HON. MADAM JUSTICE STREKAF DATED JUNE 29, 2015".
3. Any party may apply to set aside this Order upon providing the Receiver and all other interested parties (including but not limited to GA) with five (5) days notice of such application.
