INTRODUCTION

- 1. On March 18, 2016 (the "NOI Filing Date"), Graham Brothers Construction Group Ltd. ("GBCG" or the "Company") filed a Notice of Intention to Make a Proposal ("NOI") pursuant to Part III, Division I, section 50.4 of the *Bankruptcy and Insolvency Act* ("BIA").
- 2. Deloitte Restructuring Inc. ("Deloitte") is named as the trustee under the proposal in the NOI (the "Trustee").
- 3. The Company and the Trustee have fulfilled their respective obligations pursuant to BIA subsection 50.4(2), namely, the following documents were filed with the Official Receiver within 10 days after the NOI Filing Date:
 - a. Company's Statement of Projected Cash Flow, prepared to the end of May 27, 2016;
 - b. Trustee's Report on the reasonableness of the Company's Statement of Projected Cash Flow; and
 - c. Company's Report containing representations of the notes and assumptions made in the preparation of the Statement of Projected Cash Flow.
- 4. This Report is being filed pursuant to paragraph 65.13(4)(c) of the BIA as the Company is making an application under subsection 65.13(1) for an Order allowing the Company to sell or otherwise dispose of some of its assets outside of the ordinary course of business.
- 5. The Company has not yet finalized its proposal plan, however there is an application to be heard in the Court of Queen's Bench of Alberta wherein the Company plans to seek protection under the Companies Creditors' Arrangement Act.

BACKGROUND

- 6. GBCG is a privately held corporation incorporated under the laws of Alberta, which has been owned by the same family since it commenced operations in 1920. The head office is located in Edmonton and has operated throughout Western Canada for nearly 100 years.
- 7. GBCG is in the business of providing construction services to the industrial and oil and gas industries including foundation installation, site development, and right of way maintenance and reclamation. Over the past year, revenues and gross margins have decreased dramatically as a result of the challenging times being faced in the oil and gas and regional construction markets. In order to manage through a period of reduced revenue, Graham Brothers entered into two contracts in Northern Manitoba. These projects have

generated positive cash flows, however the profits have not been sufficient to service financing costs, overhead costs and losses on other projects performed by the Company.

APPLICATION FOR DISPOSAL OF ASSETS OUT OF THE ORDINARY COURSE

- 8. GBCG suspended operations shortly after the NOI Filing Date and, as a result, is carrying a surplus of capital assets. The Company wishes to dispose of these assets, most by way of auction with Ritchie Brothers Auctioneers ("Ritchie Brothers"). This sale would be out of the ordinary course of business and thus requires Court approval under subsection 65.13(1) of the Act.
- 9. The Company's reasons for wishing to dispose of assets on short notice include:
 - a. There are a limited number of auctions that are suited for the sale of some of the Company's assets;
 - b. Some of the most widely attended public actions are those conducted by Ritchie Brothers. Ritchie Brothers has an extensive network of buyers located throughout North America that participate in person and via internet at Ritchie Brothers' auction premises in Nisku Alberta.
 - c. Ritchie Brothers has a reputation as being one of the most sought after companies for liquidating the type of equipment that the Company owns.
 - d. The next scheduled Ritchie Brothers auctions at Nisku Alberta are on April 26 to 29, 2016 and then on June 14 to 16, 2016.
 - e. In order to enable Ritchie Brothers to market and advertise the Company's assets to its customer network in advance of the upcoming auction on April 26 to 29, 2016, the Company understands that it has to commit to Ritchie Brothers by April 1, 2016 that it will permit Ritchie Brothers to sell their assets.
 - f. The Company plans to liquidate all of its assets for the benefit of creditors. In doing so, all staff will eventually be laid off, holding costs such as insurance and utilities will reduce and financing costs will be reduced. The sooner the assets are disposed of, the lower future costs will be, which in turn will result in greater funds being available for creditors.
 - g. The Company is of the belief that the April 26 to 29, 2016 Ritchie Brothers sale should result in greater sales proceeds than the June 14 to 16, 2016 Richie Brothers sale.
 - h. The Company advises us that Ritchie Brothers is willing to offer the Company a minimum selling price guarantee. It is anticipated that the guarantee amount will be known prior to the

scheduled Court date for this matter. The Trustee plans to provide an updated report to the Court once the guarantee is known.

- 10. Attached as Schedule 1 is a list of assets against which there are no specific PPSA registrations by serial number, that the Company wishes to sell in the immediate future totaling approximately \$1,650,000. The estimated sales proceeds from assets to be sold at the Ritchie Brothers auction on April 26 to 29, 2016 is \$1,350,000 and the estimated proceeds from the sale via alternative means (e.g. private sale to arms-length parties) is \$300,000. As the Company normally sells redundant assets, the sale of the assets via alternative means for an estimated \$300,000 is considered to be within the normal course of operations. However the significant volume of assets proposed for the Ritchie Brothers auction would appear to be outside the normal course of business operations. In estimating the selling prices, the Company relied upon estimates of value received from a variety of auction companies, data obtained from machinery trading websites and management's experience. A 20% reduction was made for auction commissions and contingencies to arrive at estimated net proceeds of approximately \$1,300,000 from the combined Ritchie Brothers auction and other means. The Trustee has not independently reviewed the process and estimated proceeds arrived at by the Company.
- 11. Attached as Schedule 2 is a list of assets against which there are specific PPSA registrations by serial number that the Company wishes to sell at the April 26 to 29, 2016 Ritchie Brothers auction. The Company estimates the selling price to be received will be approximately \$1,300,000. The selling prices have been determined in much the same manner as that used for assets noted in the above paragraph. A 20% reduction was made for auction commissions and contingencies. As there is approximately \$850,000 owing for secured creditors that have PPSA serial number registrations, the net proceeds available for the benefit of the Company and creditors after satisfying debts owing on the PPSA registrations is approximately \$200,000. The Trustee has not independently reviewed the process and estimated proceeds arrived at by the Company.
- 12. The Trustee understands that in order for the Company to be assured of the Ritchie Brothers minimum selling price guarantee, the Company must commit to selling all assets proposed to be sold by Richie Brothers in paragraphs 10 and 11 above.
- 13. The Trustee is supportive of the Company's desire to sell assets noted on Schedules 1 and 2 at the April 26 to 29, 2016 Ritchie Brothers auction. In providing this support, the Trustee notes that Ritchie Brothers is a respected auction company that often sells assets of this nature; the April 26 to April 29, 2016 auction will include assets from many other parties and thus attract a large number of potential buyers; and if the assets are not sold at the April 26 to 29, 2016 auction, an auction process would be the likely disposal process taken at a later date, however the delay will cause increased costs.

CONCLUSION

- 14. The Trustee believes that the Company has acted, and is acting, in good faith and with due diligence in undertaking and recommending a proposed sales process which will see maximum recoveries from the sale of the subject assets.
- 15. The requested sale of assets at the April 26 to 29, 2016 Ritchie Brothers auction is consistent with the NOI Projected Cash Flow statement filed by the Company with the Official Receiver.
- 16. The Company continues to work on a plan for the orderly liquidation of its other assets.
- 17. The Trustee is not aware of any creditor that would be materially prejudiced if the sale of assets being applied for were granted by the Court.
