Notice to Depositors of the Lutheran Church – Canada, the Alberta – British Columbia District ("District"), including the Church Extension Fund ("CEF"), regarding the Creditors' Committee Selection Process

As you are aware, the District commenced proceedings under the *Companies' Creditors Arrangement Act* (the "CCAA") on January 23, 2015. Deloitte Restructuring Inc. acts as the Monitor in the CCAA proceedings (the "Monitor").

On February 20, 2015, an Order was approved which provided a process (the "Committee Process") for the establishment of two creditors' committees, one for District and one for Lutheran Church – Canada, the Alberta – British Columbia District Investments Ltd. (the "Committee(s)").

On March 19, 2015, correspondence was issued to you that included a list of those parties who had expressed an interest in participating on the Committee for the District (the "March 19 Letter"). Unfortunately subsequent to the March 19 Letter being issued, it came to our attention that one application form received by Deloitte had been erroneously excluded from the March 19 Letter. As such an updated listing of those parties who had expressed an interest in participating on the Committee for the District is attached. We note that no professional fees or expenses are being incurred by the District Group related to this correction.

As previously noted, those wishing to vote must complete the attached voting letter (the "Voting Letter") indicating their top two choices to fill the Vacant Positions. The deadline by which the Voting Letter must be received by the Monitor is no later than April 14, 2015 at 4:00 p.m. Mountain Time.

If you have already mailed a voting letter but wish to change your vote as a result of being provided with the updated list of applicants, please submit a new Voting Letter to the Monitor and the latest Voting Letter received will be treated by the Monitor as the definitive document.
