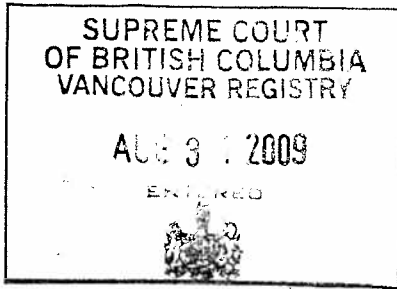



THIS COURT ORDERS AND DECLARES that:


