2. The time for filing a proposal under section 50.4(9) of the *Bankruptcy and Insolvency Act*, RSC 1985, c. B-2 (as amended) (the "BIA") is hereby extended for 45 days from May 11, 2014 to June 25, 2014.

Reporting

3. 3 Eau Claire shall provide counsel for the Korea Exchange Bank of Canada ("KEB") weekly updates during the extension period regarding its activities. KEB shall keep the information it receives in such reports strictly confidential.

Administrative Charge

- 4. All assets, rights, undertakings and properties of 3 Eau Claire, of every nature and kind whatsoever, and wherever situated including all proceeds thereof (the "Property") shall be and is hereby subject to a first charge (the "Administration Charge") in total aggregate amount of \$50,000.00 in favour of:
 - the Trustee in order to secure 3 Eau Claire's payment to the Trustee of all of the Trustee's reasonable professional fees and disbursements for professional services rendered by the Trustee in the performance of its duties both before and after the date of 3 Eau Claire filing Notice of Intention to Make a Proposal on April 11, 2014 (the "NOI"); and
 - the law firm of Miller Thomson LLP ("Miller"), legal counsel to 3 Eau Claire, in order to secure 3 Eau Claire's payment of all of Miller's reasonable professional fees and disbursements for professional services rendered by Miller for the purpose of the NOI proceedings both before and after the date of 3 Eau Claire filing the NOI.
