Further to the Interim order regarding the final settlement of the debtor's outstanding balance with the IATA clearing house and for the final distribution of BSP & CASS proceeds rendered by the Honourable Justice Brian Riordan on September 19, 2012 with respect to the above captioned matter (the «Order»), we wish to set forth certain details regarding the «Approved Process » contained at pages 3 to 6 of the Order, as follows:
