AFFIDAVIT OF DON LAL PERERA

Sworn on November 20, 2011

I, DON LAL PERERA, of Calgary, Alberta, SWEAR AND SAY THAT:

- 1. I am the Respondent and Initial Purchaser named in the Application filed on November 10, 2011 by Deloitte & Touche Inc in its capacity as Court-Appointed receiver and manager of Perera Development Corporation and Perera Shawnee Ltd, and as such have a personal knowledge of the facts and matters hereinafter deposed to, except where stated to be based upon information and belief, and where so stated, I do verily believe the same to be true.
- 2. On May 26, 2007 I executed an offer to purchase Suite 701 (the "Unit") in Phase 1 of the Highbury condominium project located at 30 Shawnee Hill SW, Calgary, Alberta (the "Project"). The Developer/Builder, Perera Shawnee Ltd. (the "Developer"), accepted this offer on May 26, 2007 (the "Purchase Agreement").
- 3. The agreed purchase price for the Unit was \$556,900.00 (inclusive of GST)(the "Purchase Price").

- 4. On or about May 4, 2007 I made an initial deposit of \$27,845.00 by cheque 1037 payable from Insight Dynamic Solutions Inc. to McCleod & Company ("McLeod") in Trust (the "First Deposit").
- 5. On or about June 4, 2007 I executed an *Addendum Additional Terms* that amended the Purchase Agreement to change the Purchaser from myself to Insight Dynamics Solutions Inc. At the time I was, and remain to this day, a Director and Shareholder of Insight Dynamics Solutions Inc.
- 6. Sometime between early June and late June 2007, Don Perera, representative of the Developer, asked me to provide additional deposits totalling \$300,000.00. Don Perera explained that financing for the Project had not been finalized, and that the Project required additional funding in order to apply for, and to obtain the required Development Permit.
- 7. On or about June 13, 2007 I agreed to provide an additional deposit of \$100,000.00 directly to Perera Shawnee Ltd in order for Perera Shawnee Ltd and/or Perera Development Corporation to apply for and obtain the relevant Development Permit, provided the \$100,000.00 was specifically credited to the purchase of the Unit. I attach hereto and mark as Exhibit "A" a copy of cheque 1039 dated June 13, 2007 payable from Insight Dynamic Solutions Inc. to Perera Shawnee Ltd (the "Second Deposit").
- 8. On or about June 13, 2007 I executed, and the Developer accepted, an *Addendum Additional Terms* that amended the Purchase Agreement to confirm, "the balance owing on completion would be \$429,055". In other words, the Developer expressly agreed that the Second Deposit was specifically provided for, and was to be applied to, the purchase of the Unit. The *Addendum Additional Terms* dated June 13, 2007 is attached as Schedule 3 to the Receiver's *Twenty Fifth Report* filed November 10, 2011.
- 9. Further, I am informed and verily believe that the Second Deposit was deposited into a bank account of Perera Shawnee Ltd and/or Perera Development Corporation on or about June 15, 2007. I attach hereto and mark as Exhibit "B" a copy of cheque but 0030 provided to me by Don Perera evidencing the deposit of \$100,000.00 into a bank account controlled by Perera Shawnee Ltd and/or Perera Development Corporation.
- 10. On or about June 29, 2007 I agreed to provide an additional deposit of \$200,000.00 directly to Perera Shawnee Ltd in order for Perera Shawnee Ltd and/or Perera Development Corporation to apply for and obtain the relevant Development Permit, provided the \$200,000.00 was specifically credited to the

purchase of the Unit. I attach hereto and mark as Exhibit "C" a copy of cheque 1048 payable from Insight Dynamic Solutions Inc. to Perera Shawnee Ltd (the "Third Deposit").

- 11. On or about June 29, 2007 I executed, and the Developer accepted, an *Addendum Additional Terms* that amended the Purchase Agreement to confirm, "the balance owing on completion will be \$229,055". In other words, the Developer expressly agreed that the Third Deposit was specifically provided for, and was to be applied to, the purchase of the Unit. The *Addendum Additional Terms* dated June 29, 2007 is attached as Schedule 4 to the Receiver's *Twenty Fifth Report* filed November 10, 2011.
- 12. Further, I am informed and verily believe that the Third Deposit was deposited into a bank account of Perera Shawnee Ltd and/or Perera Development Corporation on or about June 29, 2007. I attach hereto and mark as Exhibit "D" a copy of cheque stub 0044 provided to me by Don Perera evidencing the deposit of \$200,000.00 into a bank account controlled by Perera Shawnee Ltd and/or Perera Development Corporation. I also attach hereto and mark as Exhibit "G" a copy of the Year-to-date Ledger dated 20 March 2008 evidencing the deposit of my Second Deposit and Third Deposit into a bank account controlled by Perera Shawnee Ltd and/or Perera Development Corporation.
- 13. Further, I am informed and verily believe that the Second and Third Deposits were used, in whole or in part, towards the application for, and the obtaining of, the Development Permit for the Project. I attach hereto and mark as Exhibit "E" a copy of cheque stub 0048 dated July 6, 2007 provided to me by Don Perera evidencing the payment of \$277,979.18 to the City of Calgary with respect to Development Permit DP 2006-1891.
- 14. On or about November 12, 2009 I received a Possession Letter dated November 12, 2009 advising that the pre-possession walk-through was scheduled for December 8, 2009, and that the possession date was December 18, 2009. I attach hereto and mark as Exhibit "F" a copy of the Possession Letter dated November 12, 2009.
- 15. On or about November 16, 2009 I contacted Judy Poole, who I believed to be a representative of Perera Shawnee Ltd, and advised Ms. Poole that I would be overseas at the time of the pre-possession walk-through, and at the time of the possession date. As a result Ms. Poole promised to delay the possession date until sometime in March or April, 2010.

16. On April 6, 2010 I received a letter from Deloitte & Touche Inc ("Deloitte") advising that Deloitte had

been appointed as receiver and manager of all of the assets, properties and undertaking of Perera

Development Corporation and Perera Shawnee Ltd.

17. I am, and have always been ready, willing and able to close the purchase and sale of Suite 701 pursuant to

the terms of the Purchase Agreement by paying the balance owing, namely \$229,055.00 (the "Balance

Owing"). I have advised the Receiver, and its legal counsel, of this numerous times. I am ready, willing

and able to close the transaction by paying the Balance Owing even though the Purchase Price of

\$556,900.00 is far in excess of the market value of the Unit today. The Receiver refuses to recognise

payment of my Second and Third Deposits in the total sum of \$300,000.00, and refuses to close the

transaction.

18. I believe that the Purchase Agreement is binding and valid with a balance owing of \$229,055.00.

19. I make this Affidavit in opposition to the Application of the Receiver to disclaim the Purchase

Agreement, and request this Honourable Court to:

a. Grant an Order for specific performance of the Purchase Agreement to enforce the valid interest of Insight

Dynamic Solutions Inc. in the Unit.

b. In the alternative, to grant an Order returning in whole, or in part, the First, Second and Third Deposits:

i. by virtue of its equitable discretion to grant relief from forfeiture of the total deposit

monies, being \$327, 845.00, or

ii. on the grounds of unjust enrichment as the Receiver, all other Purchasers, and all

other creditors have directly benefited from the application of my Second and Third

Deposits to the development of the Project, in particular the obtaining of the

Development Permit, or

iii. such other ground that may be established at the hearing of this Application.
