RECEIVER'S CERTIFICATE

RECITALS

A. Pursuant to an Order of the Court dated 4 February 2011, the Court ordered the discharge of Deloitte & Touche Inc. from its appointment as Court-appointed receiver (the “**Receiver**”) of certain assets, property and undertakings of Great Glasses, SHS Optical Ltd., Dundurn Optical Ltd., Joanne Marie Bergez, Bruce Bergez (the “**Debtors**”) and the businesses operated at the locations listed on Schedule “A” (the “**Locations**”) attached hereto, upon filing a certificate certifying that (i) the Receiver has transferred possession of a pupilometer and lens kit taken from the Great Glasses location at 95 Saginaw Parkway in Cambridge, Ontario (the “**Cambridge Equipment**” and the “**Cambridge Location**”, respectively) to Steinecke Maciura LeBlanc (“**SML**”) and (ii) the Receiver has destroyed the computer disks containing copies of the computer records


copied from certain of the Debtors and businesses operated at the Locations (the "Computer Disks").

THE RECEIVER CERTIFIES the following:

1. The Receiver transferred possession of the Cambridge Equipment to SML on 10 February 2011.
2. The Receiver caused the Computer Disks to be destroyed on or about 18 February 2011.
