**TO THE EMPLOYEES AND CREDITORS OF UTEX CORPORATION ("Utex")**

Our letter dated January 30, 2012 advised you that, with much sadness, after 70 years in business, Utex had to file a Notice of Intention to Make a Proposal ("NOI") under the provisions of the *Bankruptcy and Insolvency Act*(Canada) (the "BIA")on January 24, 2012.The firm of Deloitte & Touche ("Deloitte") in Montréal was appointed to supervise our restructuring. This was necessary due to the financial losses in our business resulting from declining sales volume and due to our retail customers importing directly from China. Other problems during the past five years included the 2008 economic crisis and increased competition from major brands in our market.

The filing has given us the opportunity to realize on our assets and to maximize the recoveries for all our stakeholders. Indeed, since the filing, we have collected our outstanding receivables and realized our inventory through sales to many of our regular customers. We have also made arrangements so that numerous purchase commitments have been assumed by third parties, thereby reducing supplier claims for the overall benefit of the creditors. We have used the funds recovered to repay our bank loans in full at this date which was in excess of \$3.5 million at the date of the filing. The Bank was fully secured and had to be repaid prior to our other creditors. As required by the BIA, we have also paid all of our operational expenses since the filing.

We are pleased to advise you that, as a result of the diligent efforts of our Management team and our continuing employees to maximize recoveries, we now can estimate that, upon the final realization of our remaining assets, \$750,000 will be available to distribute to our employees and creditors. This amount represents an estimated payment of approximately 15% to 20% of your claims. However, the final payment percentage will only be determined based upon the final approved claims of the employees and creditors. As well, further to the terms of the Proposal, the smaller claims of employees and creditors will be substantially repaid as they will receive the lesser of their claim or \$1,000.

Deloitte, as Trustee to our Proposal, is attaching to this letter a copy of the Proposal as well as a Proof of Claim form and Voting Letter. Within approximately one week, Deloitte will be forwarding to all employees and creditors their detailed report which will include their recommendation that all creditors and employees support our Proposal at the First Meeting of Creditors to be held on June 7, 2012.

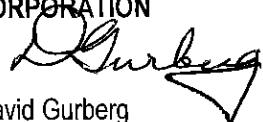

PROPOSAL

We, **UTEX CORPORATION** ("Utex"), the above-noted Debtor (hereinafter referred to as the "Company"), hereby submit the following proposal under the Bankruptcy and Insolvency Act:

1. For purposes hereof:

"ACT" means the Bankruptcy and Insolvency Act, as amended from time to time;

"APPROVAL" means the situation arising from the PROPOSAL having been duly accepted by the creditors of the COMPANY and having been duly approved by the COURT in a Judgment which has become executory as a result of the delay for appeal having expired without there having been an appeal, or an appeal having been lodged and the Judgment having been confirmed or the appeal withdrawn or otherwise settled;

"CLAIM" means the CLAIM of any CREDITOR of the COMPANY, whether it is a SECURED CLAIM, a PREFERRED CLAIM or an UNSECURED CLAIM;

"COMPANY" means Utex Corporation;

"COURT" means the Superior Court of the District of Montréal sitting in bankruptcy and insolvency matters (Commercial Division);

"CREDITOR" means the holder of a CLAIM;

"EMPLOYEE CLAIMS" means the calculation of employee's claim, including any severance claims, as shown on the notice sent to each employee together with this PROPOSAL. Should the employee be in agreement with the amount shown on such notice for his (her) CLAIM, then there will be no need to file a proof of claim and his (her) claim shall be accepted, for all intent and purposes. Otherwise, the employee shall file his (her) CLAIM, prior to the first meeting of creditors, together with any and all supporting documents, and a proper statement of account, and same shall then be dealt with pursuant to the Act.

"LANDLORDS" means those creditors of which the COMPANY was a commercial tenant under a lease of real property, as acknowledged by the COMPANY;

"LANDLORDS CLAIMS" means the UNSECURED CLAIMS of the LANDLORDS for the actual losses resulting from the disclaimers of ordinary leases in accordance with 65.2(4)b of the ACT, which CLAIMS shall be treated as UNSECURED CLAIMS in accordance with Section 65.2(5) of the ACT;

"NOTICE OF INTENTION" means the respective Notice of Intention to Make a Proposal under the ACT filed by Utex on January 24, 2012;

"PREFERRED CLAIMS" means all claims of the COMPANY directed by the ACT to be paid in priority by the COMPANY to all other claims in the distribution of the property of an insolvent party;

"PREFERRED CREDITOR" means the holder of a PREFERRED CLAIM;

"PROPOSAL" means this Proposal;

"PROPOSAL EXPENSES" means all fees, expenses, liabilities and obligations of the TRUSTEE, and all legal fees, consulting fees and accounting fees on and incidental to the proceedings arising out of the NOTICE OF INTENTION and the PROPOSAL and including without limitation advice to the COMPANY and the TRUSTEE in connection therewith;

"PROVEN CLAIM" means the amount accepted by the COMPANY for any CLAIM, or further to the Court's determination and then as per the final judgment to be rendered and that the delay of appeal has expired without having been an appeal, or an appeal having been lodged and the judgment having been confirmed or the appeal withdrawn or otherwise settled. For an EMPLOYEE'S CLAIM, the amount which appears on the notice sent to each employee, unless the employee has chosen to file a proof of claim for a different amount, in which case it shall be dealt with as any other CLAIM;

"SECURED CLAIMS" means claims of secured creditors within the meaning of the ACT;

"SECURED CREDITOR" means the holder of a SECURED CLAIM;

"SETTLEMENT FUND" means the amount of \$750,000 to be remitted by the COMPANY to the TRUSTEE upon APPROVAL; for distribution to the Preferred Creditors and then the UNSECURED CREDITORS in full and final settlement of their CLAIMS against the COMPANY;

"TRUSTEE" means Samson Bélair/Deloitte & Touche Inc., the Trustee under the Notice of Intention and the Trustee named in the Proposal of the COMPANY;

"UNSECURED CLAIMS" means in respect of the COMPANY, the claims of the UNSECURED CREDITORS including claims of every nature and kind whatsoever, whether due or not due for payment as of the date of the filing of the NOTICE OF INTENTION as well as contingent or unliquidated claims arising out of any transaction entered into by the COMPANY prior to the date thereof, including EMPLOYEE CLAIMS and any and all CLAIMS so included pursuant to Section 121 of the ACT;

"UNSECURED CREDITORS" means in relation to the COMPANY, the ordinary, unsecured creditors of the COMPANY including LANDLORDS, which are holders of UNSECURED CLAIMS;

2. The SECURED CLAIMS shall be paid in accordance with arrangements existing between the COMPANY and the holders of SECURED CLAIMS or as may be arranged between the COMPANY and the holders of SECURED CLAIMS. The COMPANY declares that this PROPOSAL is not made in respect of the CLAIMS of the SECURED CREDITORS;
3. Amounts:
  - (a) owing to Her Majesty in right of Canada or a Province that could be subject to a demand under Section 224 (1.2) of the Income Tax Act, or under any substantially similar provision of provincial legislation, outstanding at the time of the filing of the NOTICE OF INTENTION, will be paid in full within six (6) months after APPROVAL, as per the ACT;
  - (b) owing to employees and former employees, that they would have been entitled to receive under Paragraph 136(1)(d) of the ACT if the employer became bankrupt on the date of the filing of the NOTICE OF INTENTION, as well as wages, salaries, commissions or compensation for services rendered after that date and before the APPROVAL, will be paid in full immediately after APPROVAL as per the ACT.
4. The PROPOSAL EXPENSES shall be paid by the COMPANY in priority to all UNSECURED CLAIMS and PREFERRED CLAIMS;
5. Payment of the claims of the holders of PREFERRED CLAIMS other than those referred to in Section 3(b) hereof will be paid in full in priority to all UNSECURED CLAIMS, sixty (60) days after APPROVAL;
6. Debts arising in respect to goods supplied, services rendered or other consideration given as and from the date of the filing of the NOTICE OF INTENTION, including amounts owed to LANDLORDS of the COMPANY where the COMPANY is a commercial tenant under a lease of real property (up to the effective date of disclaimer of such leases pursuant to Section 65.2(1) of the ACT), will be paid by the COMPANY in full in the ordinary course of business and on regular trade terms or as may be arranged by the COMPANY;
7. The COMPANY will remit to the TRUSTEE, upon APPROVAL, the SETTLEMENT FUND to be distributed by the Trustee as follows:
  - (a) firstly, an amount equal to the COMPANY's PREFERRED CLAIMS of the PREFERRED CREDITORS that have filed a proof of claim, to be paid in accordance with paragraphs 3 and 5 above;
  - (b) the balance, to be paid to each of the COMPANY'S UNSECURED CREDITORS that have filed a proof of claim, in full and final settlement of its UNSECURED CLAIMS, without interest, as follows:
    - (1) the lesser of: (i) the amount of the PROVEN CLAIM of such UNSECURED CREDITOR and (ii) CAD\$ 1,000.00 (the "First Level Distribution") (pro rated in the event of any shortfall) which amount, subject to paragraph c) below, shall be received within sixty (60) days after APPROVAL;
    - (2) an amount equal to such UNSECURED CREDITOR's pro rata share, based on the remaining amount of its PROVEN CLAIM, of any amount remaining from the SETTLEMENT FUND after the distribution of all of the First Level Distribution amounts, and subject to paragraph c) below, to all UNSECURED CREDITORS ("Second Level Distribution"). The Second Level Distribution will be paid by the Trustee as follows:
      - (i) 70% of the Second Level Distribution, 60 days after APPROVAL;
      - (ii) the balance of 30% of the Second Level Distribution, 120 days after APPROVAL.

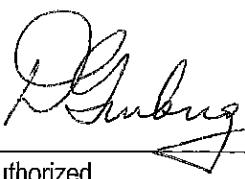
- (c) the distribution referred to in a) and b) above shall be net of any amount to be set aside by the TRUSTEE while CLAIMS are being determined, litigated or for any disputed CLAIM . The TRUSTEE shall use its best judgment in the determination of any amount which should be set aside, and for which period.
8. Conditionally upon APPROVAL, the statutory terms of Sections 95 to 101 of the ACT (preferences, transfers of undervalue, etc.) shall not apply, the whole pursuant to Section 101.1 of the ACT;
9. In accordance with Section 50(13) of the ACT, the PROPOSAL herein made will constitute a compromise of claims against the present and past directors of the COMPANY that arose before the filing of the NOTICE OF INTENTION and that relate to the obligations of the COMPANY where the directors are by law liable in their capacity as directors for the payment of such obligations, and acceptance of the PROPOSAL, upon APPROVAL, will operate as a discharge in favour of such present and past directors with respect to such obligations. Nothing herein shall be interpreted as an acknowledgement of any liability or obligation of the directors of the COMPANY;
10. The UNSECURED CREDITORS having a PROVEN CLAIM and having an UNSECURED CLAIM of an amount lesser than or equal to \$1,000.00 shall be deemed to have voted in favour of the PROPOSAL. Likewise, any employee that has not filed a proof of claim, prior to the first meeting of creditors, and therefore that is bound by the COMPANY's determination of his (her) EMPLOYEE CLAIM shall be deemed to have voted in favour of the PROPOSAL. Notwithstanding the foregoing, the UNSECURED CREDITORS and the EMPLOYEES described in the present clause may vote against the PROPOSAL during the creditors' vote on the PROPOSAL.
11. Samson Bélair/Deloitte & Touche Inc., Licensed Trustee, will be the TRUSTEE under the PROPOSAL and all monies payable under the PROPOSAL will be paid over to the TRUSTEE which will remit the dividends in accordance with the terms of the PROPOSAL.

IN THE EVENT OF ANY DISCREPANCY BETWEEN THE ENGLISH AND THE FRENCH VERSION OF THIS PROPOSAL, THE ENGLISH VERSION WILL TAKE PRECEDENCE.

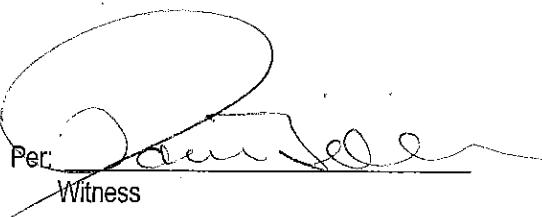
