ORDER

UPON THE APPLICATION of Deloitte & Touche Inc. in its capacity as the Court-appointed Receiver and Manager (the "Receiver") of the Defendant, Whitemud Resources Inc. ("Whitemud"); AND UPON hearing from counsel for the Receiver and counsel for the other

interested parties; AND UPON reviewing the First Report of the Receiver dated March 23, 2011 (the "First Report") and the Confidential Supplement to the First Report of the Receiver dated March 28, 2011 (the "Confidential Supplement");

IT IS HEREBY ORDERED AND DIRECTED THAT:

1. The Receiver's reported actions are hereby approved.
2. The Sales Process, as that term is defined in the First Report, is approved.
