AFFIDAVIT

- I, Mary O'Sullivan-Andersen, of 2401 United Boulevard, Coquitlam, British Columbia, businesswoman, SWEAR THAT:
- 1. I am the Chief Operating Officer of Williams Moving & Storage (B.C.) Ltd. (the "Company"), the debtor in these proceedings, and as such have personal knowledge of the facts hereinafter deposed to except where stated to be on information and belief, in which case I verily believe them to be true.
- 2. On January 21, 2015, the Company filed a Notice of Intention to Make a Proposal (the "NOI") pursuant to section 50.4 of the *Bankruptcy and Insolvency Act* (the "BIA"). Deloitte Restructuring Inc. was appointed as trustee under the NOI (in such capacity, the "NOI Trustee").
- 3. By an Order dated February 19, 2015 the time for filing the Company's proposal was extended to 11:59 p.m. on Monday, April 6, 2015.

- 4. As part of its process to realize on the value of its assets, the Company issued a request for proposals (the "RFP") on February 3, 2015 seeking offers to sell and/or purchase the Company's rolling stock equipment (the "RS Equipment"), located at various of the Company's premises in British Columbia and Alberta (the "Premises"). The RFP was issued to five parties which the Company considered to have the relevant experience and capability to deal with the sale of the RS Equipment. RFP Responses were due by February 12, 2015.
- 5. The Company received and considered four proposals in response to the RFP, all from arm's length parties, three of whom are well-known, experienced auctioneers. The proposals included offers for the outright purchase of the RS Equipment, net minimum guarantee sales and straight commission sales. The Company, with the assistance of the NOI Trustee, completed a comparison of the proposals on a 'like for like' basis, considering the following factors:
 - (a) gross proceeds;
 - (b) costs charged for transporting certain of the RS Equipment;
 - (c) costs charged for refurbishment of the RS Equipment;
 - (d) advertising costs;
 - (e) commission charged;
 - (f) minimum net proceeds; and
 - (g) potential upside to the Company.

to determine which proposal provided the best return to the Company for the RS Equipment, taking into account the risks associated with each proposed method of sale.

6. On the basis of its review and comparison, the Company determined that the proposal received from Maynards Industries Ltd. ("Maynards") providing for a net minimum guarantee sale of the RS Equipment was the superior proposal, and in the best interests of the Company and its creditors. While a straight commission sale may have potentially achieved a higher return to the Company, given the additional risk associated with the uncertainty of the gross sale proceeds

achievable on a sale of the RS Equipment, the Company did not consider the possible higher return to be worth the increased risk.

- 7. On March 6, 2015, the Company and Maynards entered into an auction and liquidation services agreement (the "Liquidation Agreement"), pursuant to which Maynards will sell the RS Equipment by way of auctions (both online and at certain of the Premises) and/or by private sale, at Maynards' discretion, with the sales process to be completed by no later than April 30, 2015.
- 8. In summary, the Liquidation Agreement provides for a net minimum guaranteed amount to the Company (the "NMG"), together with the possibility of sharing the proceeds of sale beyond a set threshold with Maynards in the ratio of 90:10, with 90% of the proceeds going to the Company. Maynards is entitled to an Expense Budget (defined in the Liquidation Agreement), on account of advertising, travel, sale preparation, minor refurbishing of equipment and relocating certain of the RS Equipment from two of the Premises, and a Relocation Budget (defined in the Liquidation Agreement), on account of Maynards' costs of moving certain of the RS Equipment from third party locations to one or more of the Premises.
- 9. The Liquidation Agreement also provides that any of the RS Equipment remaining after completion of the sales process is to be removed from the Premises and scrapped at Maynards' sole risk, cost and expense. In the event that any of the RS Equipment is not in fact sold for scrap but is instead sold by Maynards within three months of the date of the Liquidation Agreement, the proceeds of any such sales are to be shared between the Company and Maynards in the ratio of 90:10, with 90% of the proceeds going to the Company.
- 10. The Liquidation Agreement is conditional on Court approval on or before March 9, 2015, or such later date as the Company and Maynards may agree. Given the timing of the execution of the Liquidation Agreement, the Company and Maynards have agreed that that date be extended to March 10, 2015. Accordingly, the Company is seeking an order approving the Liquidation Agreement, authorizing the Company to execute and implement the Liquidation Agreement, and vesting the assets sold pursuant to the Liquidation Agreement in the various purchasers thereof, free and clear of all encumbrances.

- 11. Attached hereto as **Exhibit "A"** is a copy of the results of a search of the Company made at the British Columbia Personal Property Registry on March 5, 2015.
- 12. Attached hereto as **Exhibit "B"** is a copy of the results of a search of the Company made at the Alberta Personal Property Registry on March 5, 2015.
- 13. The following entities are shown as secured parties in respect of registrations in the British Columbia and/or Alberta Personal Property Registries in relation to some or all of the RS Equipment:
 - (a) Business Development Bank of Canada ("BDC");
 - (b) Dundarave Mortgage Investment Corporation ("Dundarave");
 - (c) BCMP Mortgage Investment Corporation by its administrative agent Pen-Cor Mortgage and Investment Advisors Ltd. and Pencor Capital Corp. ("Pencor");

(collectively, the "Registered Parties"). While the Company has not yet had the opportunity to review the validity of the underlying security interests of all of the Registered Parties, notice of this application will be given to each of the Registered Parties.

14. I am advised by Vicki Tickle, of Fasken Martineau DuMoulin LLP, counsel for the Company, that the Liquidation Agreement contains information that Maynards believes should

not be made public and that Maynards will be applying for an order providing that the affidavit of Maynards' representative attaching a copy of the Liquidation Agreement be filed under seal. However, I can confirm that the NMG is well in excess of the value of any liens or charges that are the subject of serial number registrations in favour of the Registered Parties. Particulars of the Liquidation Agreement have been provided, with Maynards' approval, to BDC, Dundarave and Pencor.

15. I swear this affidavit in support of the Company's application for orders authorizing it to enter into the Liquidation Agreement, as well as other related relief.
