- 2. Attached as Schedule "A" is the results of a search I performed on June 18, 2021 of the Judgment Roll in the Halifax Land Registry Office pursuant to the *Land Registration Act*, confirming that no judgments were recorded against the Company.
- 3. Attached as Exhibit "B" is a printout of all registrations against the Company under the Personal Property Security Act (Nova Scotia) as of June 18, 2021, confirming that no new registrations were made against the Company since my affidavit sworn on April 15, 2021 in this proceeding.
- 4. True copies of the invoices issued by Wickwire Holm in this receivership between January 22 and May 31, 2021 are set out in Appendix "C" to the Third Report of the Receiver with solicitor-client privileged information redacted where necessary.
- 5. The total fees charged by Wickwire Holm from January 22 to May 31, 2021 were \$30,934.00 plus HST of \$4,669.99 and disbursements of \$737.25 for a total of \$36,340.74.
- 6. The invoices are a fair and accurate description of the services provided and the amounts charged.

7. To the best of my knowledge, the rates charged by Wickwire Holm are comparable to those charged by other law firms in Halifax for similar services.


