

#### Remedy claimed or sought:

- 1. An Order approving the distribution of the Claims Reserve (as defined in the Order granted by this Honourable Court herein on February 21, 2013, hereinafter the "Bridges Settlement Agreement Order") as follows:
  - (a) \$1,085,000 to The Toronto-Dominion Bank ("TD");
  - (b) \$112,960 to Lear Construction Ltd. ("Lear");
  - (c) \$51,019.88 to Paycon Holdings Ltd. ("Paycon"); and
  - (d) \$51,019.87 to Evolution by Greenboro Limited Partnership ("Evolution LP"); and
- 2. such further and other relief as counsel may advise and this Honourable Court deems just.

#### Grounds for making this application:

- 3. Pursuant to the Settlement Agreement Order, counsel to the UBG group of companies has been holding the Claims Reserve, in the amount of \$1.3 Million, with respect to the Bridges Project.
- 4. The Monitor has reviewed the books and records of the UBG group of companies and determined that the only unpaid creditors of UBG Bridges Limited Partnership ("Bridges LP") are TD, a secured creditor, and Lear, an unsecured creditor.
- 5. The proposed payments to TD and Lear as set out in paragraph 1 hereof will pay in full TD's and Lear's creditor claims against Bridges LP.
- 6. The Monitor has reviewed the books and records of the UBG group of companies and determined that Paycon and Evolution LP are equity owners of Bridges LP and as such have equity claims against Bridges LP, which may be repaid in the event that all creditors of Bridges LP are first repaid.
- 7. The proposed payments to Paycon and Evolution LP as set out in paragraph 1 hereof will partially repay Paycon's and Evolution LP's equity claims.
- 8. Such further and other grounds as counsel may advise.

- 9. The Report of the Monitor in Respect of the Bridges Project, dated October 3, 2013, filed;
- 10. The Bridges Settlement Agreement Order, filed:
