Please take notice that on February 14, 2020 (the "Filing Date"), Artiva Inc. (the "Company") filed a Notice of Intention to Make a Proposal (the "NOI") pursuant to Section 50.4(1) of the *Bankruptcy and Insolvency Act* (the "BIA") and Deloitte Restructuring Inc. has been named as Trustee ("Deloitte" or the "Trustee") under the NOI. Related entities Eureka 93 Inc., LiveWell Foods Canada Inc. and Vitality CBD Natural Health Products Inc. The Company is continuing to operate and maintain its business in the ordinary course during the NOI proceedings and the Trustee is required to monitor the Company's business and affairs during the Stay and to report any material adverse changes to the Office of the Superintendent of Bankruptcy and the Court.

The Company has negotiated for new financing called "debtor-in-possession" or "DIP" financing to provide additional liquidity during the NOI proceedings for which it will be seeking Court approval. The Company will also be seeking an administrative consolidation of its proposal proceedings with the Related Entities.

The NOI generally prohibits the Company from paying for goods and services that were received on or before the Filing Date and if you are owed monies for goods or services supplied on or before the Filing Date, you will have the opportunity to file a Proof of Claim once a claims process is established. Suppliers should provide invoices to the Company for goods and services delivered up to and including Filing Date and prepare separate invoices for all goods and services delivered after the Filing Date.
