As you may be aware on July 17, 2020, Deloitte Restructuring Inc. was appointed as Receiver of the Debtor by the Quebec Superior Court (Commercial Division). A copy of the Receivership Order can be found at: www.insolvencies.deloitte.ca/Bouclair

As a result of legislation introduced on July 7, 2008, and amended December 15, 2011, the Government of Canada will provide timely payment of unpaid wages, vacation, termination and severance pay (if applicable) for eligible workers who have lost their job because their employer declared bankruptcy or became subject to a receivership.

In accordance with paragraph 21 (1)(c) of the *Wage Earner Protection Program Act* (Canada) (the "Act"), Deloitte Restructuring Inc. in its capacity as Receiver of Bouclair hereby gives notice of the existence of the Wage Earner Protection Program ("WEPP") and advises that the date of the Receivership is July 17, 2020.

Additional information, including what the definition of "wages", eligibility requirements, and an application for payment from Service Canada for this program can be obtained at the web address provided below. Eligibility will be determined in accordance with the Act, which can be located at: http://www.servicecanada.gc.ca/eng/sc/wepp/.

Enclosed please find:

- 1. Proof of claim form (Form 31) and Schedule "A" which has been completed for you.
- 2. A copy of the information submitted to Service Canada by the Receiver, with respect to any wages, vacation pay and termination pay owed to you.

The following steps are required in order for you to file a claim under the Act:

- 1. Review Schedule "A" for amounts owing to you as at July 17, 2020 (date of Receivership). If there are any discrepancies between the amount on Schedule "A" and your records, you can send an email to bouclair@deloitte.ca.
- 2. Review your proof of claim form (Form 31). Ensure the form is <u>signed and witnessed</u>, as required. Send a copy of the proof of claim to:

3. **Register your claim** with Service Canada at the URL address below in order to be considered for WEPP or attend at a Service Canada location to register. In order to register, you will require the information contained on Schedule A, including the estate number which is 41-344553.
