The receiver gives notice and declares that:

1. On the 29<sup>th</sup> day of August, 2023, Deloitte Restructuring Inc. ("**Deloitte**") was appointed by an Order of the Supreme Court of British Columbia (the "**Receivership Order**") as the Receiver and Manager (the "**Receiver**") of the property of CanWest Aerospace Inc. ("**CW Aerospace**") and Can West Global Airparts Inc. ("**CW Airparts**", together with CW Aerospace, the "**Companies**") including, without limitation, all of the Companies' assets, undertakings and properties of every nature and kind whatsoever, and wherever situated, including proceeds thereof (the "**Property**"), as described below:

Notes

- (1) Cash is the total balance in the Companies' bank accounts as of August 31, 2023.
- (2) Accounts receivable is per management's listing dated September 6, 2023. It includes \$148k in respect of a contract with the Ecuador Army.
- (3) The inventory value is derived from the book value as of April 21, 2023. The Receiver understands that inventory may include certain consignment inventory and third-party owned parts. The book value of inventory may not be up-to-date and could be subject to material change.
- (4) The tools and equipment are primarily bespoke testing and parts assembly/overhaul tools. The value is derived from the book value as of April 21, 2023.
- (5) CW Aerospace has a contract with the Government of the People's Republic of Bangladesh for the supply of Emergency Medical Services helicopter parts (the "**Bangladesh Contract**"). The value shown is a high-level estimate of the current value of work-in-progress.
- (6) The work-in-progress amount is the total book value based as of April 21, 2023 (excluding the Bangladesh contract).

2. As noted above, Deloitte became the Receiver by virtue of the Receivership Order, which can be viewed and downloaded at the Receiver's website, as follows:

- (1) RBC holds a first-ranking security interest over all of the Companies' property, except for the Wire Marker (see note 2).
- (2) We understand that BDC holds a first-ranking security interest on the Wire Marker piece of equipment.
- (3) Estimated statutory priority claims include those amounts that could be subject to a demand under the *Income Tax Act*, the *Employment Insurance Act* or the *Canada Pension Plan*. Amounts are estimates as of September 6, 2023.
- (4) These claims consist of amounts owing to professionals secured by the Administration Charge under the Companies' CCAA proceedings, and are subject to a combined maximum remaining secured claim of \$125,000.
