**RE: In the Matter of the Notice of Intention to file a Proposal of CatalX CTS Ltd., Court File No. B301-223290 – Hearing on the Calgary Commercial List on January 6, 2026 at 10:00 a.m.**

We are counsel to the Alberta Securities Commission (“ASC”), an interested party in relation to the Notice of Intention to Make a Proposal proceedings of CatalX CTS Ltd. (the “**Debtor**”).
