Motion

Deloitte Restructuring Inc., court appointed receiver of the Respondent (the "Receiver"), moves for an order:

- 1. Approving the actions of the Receiver to date as described in the Third Report of the Receiver;
- 2. Taxing and approving the accounts and expenses of the Receiver and its counsel;
- 3. Authorizing a distribution of funds from the Receiver to (i) the Applicant; (ii) Loon Lake Developments Limited; and (iii) Dexter Construction Company Limited;
