The Receiver gives notice and declares that:

 On the 9th day of August, 2024, Deloitte Restructuring Inc. ("Deloitte") was appointed by an Order of the Supreme Court of British Columbia (the "Receivership Order") as the Receiver (the "Receiver") without security, of certain assets of G3 Genuine Guide Gear Inc. (the "Company"), including proceeds thereof, as described below.

More specifically, as outlined in paragraph 2 of the Receivership Order, the Receiver's appointment is limited to all personal property, real property, assets, effects, and undertakings of the Company, including all proceeds from such assets (collectively, the "Affected **Property**"). The Receiver is not appointed over and has no responsibility for the Company's intellectual property or the Company's key-man life insurance policy as FWCU Capital Corp. ("FWCU") has a first-ranking charge on these assets (the "FWCU Collateral", collectively with the Affected Property, the "Property").

- (1) The Receiver understands that RBC holds a first-ranking security interest over all of the Property, except for the FWCU Collateral, pursuant to the subordination and standstill agreement dated June 6, 2017 (the "Subordination Agreement").
- (2) The Receiver understands that FWCU holds a security interest in the FWCU Collateral under the Subordination Agreement, which provides FWCU priority over RBC concerning the FWCU Collateral.
- (3) The Receiver understands that there is a lease between the Debtor and Mercedes for a Mercedes Sprinter Cargo Van, model 2C144X.
- (4) Statutory priority claims include those amounts that could be owing to CRA, the Province or WorkSafeBC under the *Income Tax Act*, the *Employment Insurance Act*, the *Canada Pension Plan or* other statutes. The Receiver is not aware of any amounts outstanding but is currently awaiting information from Management and third parties to confirm.
