Fourth Interim Report of the Receiver and Manager (Subsection 246(2) of the *Bankruptcy and Insolvency Act*)

INTRODUCTION

- Pursuant to an Order (the "Receivership Order") of the Supreme Court of British Columbia (the
 "Court") dated February 3, 2020 (the "Date of Receivership"), Deloitte Restructuring Inc. was
 appointed as receiver and manager (the "Receiver"), without security, of all of the assets,
 undertakings and property of the Company, in addition to the property listed on Schedule "A" of the
 Receivership Order of Dwayne Grabher ("Mr. Grabher") and Chelsea Grabher, also known as Chelsea
 Fouillard, acquired for, or used in relation to a business carried on by the Company, including all
 proceeds thereof (the "Property"). The Court proceedings in which the Receiver was appointed are
 referred to herein as the "Receivership Proceedings".

- 3. This is the fourth interim report pertaining to the Receivership Proceedings, issued pursuant to subsection 246(2) of the *Bankruptcy and Insolvency Act*.
- 4. On the Date of Receivership, the Receiver took possession of the Property as described below:

STATEMENT OF RECEIPTS AND DISBURSEMENTS

- 5. The Receiver's interim statement of receipts and disbursements for the period from the Date of Receivership to September 20, 2023 is attached hereto as Appendix 1. During this period the Receiver has realized a total of \$3,108,377 comprised of:
 - a. \$1,850,000 from the sale of the ranch land and buildings;
 - b. \$541,831 from the sale of bison;
 - c. \$418,760 from the collection of accounts receivable;
 - d. \$248,350 from the sale of machinery and equipment;
 - e. \$11,864 from the transfer of funds held at TD Canada Trust; and
 - f. \$37,572 from the sale of pipe inventory, GST refunds and interest on deposits.
- 6. During this same period, the Receiver has made an interim distribution to the secured creditor, Bank of Nova Scotia, in the amount of \$2,687,000, and has made payment to WorkSafeBC in respect of its lien claim in the amount of \$1,376. Further disbursements totaling \$265,919 have included, among other items, appraisal fees, sales commissions, insurance costs, legal fees and the Receiver's fees.
- 7. As at September 20, 2023, the Receiver had an excess of receipts over disbursements held in the Receiver's trust account amounting to \$154,083.

STATEMENT OF UNREALIZED PROPERTY

- 8. As at the date of this report, the following Property remains to be realized by the Receiver:
 - a. Proceeds of \$281,894 from three transactions involving the sale of bison owned by the Company by a related partnership, GWG Trucking, where no apparent consideration was paid to the Company; and
 - b. Missing bison and equipment, or the proceeds related to the sale of these assets. Based on a review of the Company's asset registers and the Receiver's inventory of assets taken upon its appointment, it appears that there are a large number of bison and several pieces of equipment that are unaccounted for. Mr. Grabher was the sole shareholder of the Company and operator of the ranch. Mr. Grabher has failed to provide the Receiver with any substantive information in relation to the sale/movement of the missing bison and assets.
- 9. The Receiver has filed a Notice of Civil Claim in respect of the above noted matters and has made various requests for information from legal counsel for GWG Trucking.
- 10. The Receiver has filed a property claim in relation to the Company's 50% ownership interest in a 2013 Jayco trailer and a Hammerhead Fire Fish Boat with the Trustee dealing with Mr. Grabher's personal bankruptcy estate. The Receiver expects to receive net proceeds from the sale of these assets in the next 60 days from the Trustee.
- 11. The timing for completion of the Receivership Proceedings is unknown at this time and will depend on the Receiver's progress related to its investigations and recovery actions.
- 12. Further details regarding the Receiver's activities and administration of the Receivership Proceedings are detailed in the Receiver's Second Report to Court dated November 2, 2020, which is available for viewing on the Receiver's website noted in paragraph 2 above.
