FORM 87 NOTICE AND STATEMENT OF THE RECEIVER

(Pursuant to subsection 245(1) and 246(1) of the *Bankruptcy and Insolvency Act*)

IN THE MATTER OF THE RECEIVERSHIP OF I4PG HASTINGS STREET INC. AND HASTINGS STREET LIMITED PARTNERSHIP IN THE CITY OF VANCOUVER IN THE PROVINCE OF BRITISH COLUMBIA

The Receiver gives notice and declares that:

1. On February 14, 2025, pursuant to an order (the "Receivership Order") of the Supreme Court of British Columbia (the "Court"), Deloitte Restructuring Inc. was appointed as receiver (the "Receiver"), without security, of the lands at 4437 Hastings Street, Burnaby, BC with PID: 031-340-741 (the "Lands") and all personal property of I4PG Hastings Street Inc. ("HSI"), Hastings Street Limited Partnership ("HSLP") and I4 Property Group Inc. ("PGI") located at, related to or derived from the Lands, and the share of the nominee (together with the Lands, the "Property"), as described below:

Notes

- (1) The Receiver understands that HSI is the legal owner of the Lands and the general partner of HSLP. The development project located on the Lands is known as "Siena". It is partially constructed to the second level of the parkade. The Lands were assessed at a value of \$12,269,000 by BC Assessment as of July 1, 2024.
- * To date, the Receiver has not been able to obtain the financial statements of HSI and HSLP. The only asset the Receiver is aware of is the Lands noted above. The Receiver has not audited, reviewed or otherwise attempted to verify the accuracy or completeness of the information, and accordingly, expresses no opinion or other form of assurance on the information contained herein.
- 2. The Receivership Order was granted pursuant to an application made by Desjardins Financial Security Life Assurance Company ("Desjardins") on February 14, 2025. A copy of the Receivership Order and materials relating to the proceedings may be viewed at the Receiver's website at:

3. The Receiver took possession and control of the Property on February 14, 2025.

Notes

- (1) Desjardins holds a first-ranking mortgage and assignment of rents on the Lands. As of October 30, 2024, Desjardin's was owed \$14,546,900 under the mortgage and interest continues to accrue. PGI is a guarantor of the debt owing to Desjardin. The Receiver understands that Desjardins has also provided a letter of credit and overdraft facility to HSI, and the amount outstanding under these facilities may not be reflected in the amount shown as owing to Desjardin.
- (2) The Receiver understands that Travelers Insurance Company of Canada ("**Travelers**") has provided a deposit protection insurance policy to HSI and holds a second-ranking mortgage in the amount of \$5,500,000 and assignment of rents on the Lands. The amount of any liability owing to Travelers is currently unknown.
- (3) The Receiver understands that Longthorn Holdings Ltd. ("Longhorn") holds a third-ranking mortgage on the Lands. As of February 14, 2025 the principal owing to Longthorn pursuant to a loan agreement with HSLP amounted to \$700,000 and interest continues to accrue.
- (d) The Receiver understands that a number of contractors have registered builders lien claims on the Lands. These claims total approximately \$2,477,427.
- (e) A list of other known and possible creditors of HSI and HSLP and the amount owed to each creditor is attached hereto as **Appendix "A"**. The creditor listing is based on the available books and records of HSI and HSLP as of February 14, 2025.
- (f) The intended plan of action of the Receiver is to monetize the Property in a manner that maximizes realizations for creditors. This is expected to include marketing the Property through a sale and investment solicitation process undertaken by the Receiver.
