### **INTRODUCTION**

- On September 24, 2025 (the "Appointment Date"), Deloitte Restructuring Inc. ("Deloitte") was appointed as receiver and manager (the "Receiver") of Lamp Holdings Inc. ("LHI" or the "Company") pursuant to security held by the Toronto-Dominion Bank ("TD").
- 2.
