TAKE NOTICE that an application will be made on behalf of the Petitioners in these proceedings (collectively, the "Medican Group" or the "Applicants") before the Honourable Justice C.A. Kent, in Chambers, at the Calgary Courts Centre, 601 - 5th Street SW, in the City of Calgary, Province of Alberta on Thursday the 12th day of August, 2010 at 9:00 o'clock in the forenoon or so soon thereafter as counsel may be heard, for the following relief:

- 1. Declaring service of notice of this application and the supporting materials to be good and sufficient, and abridging the time therefor, if necessary.
- 2. An Order, substantially in the form of the Order attached hereto as Schedule "A":

- (a) approving the financing arrangement between Medican (Red Deer Michener Hill) Developments Ltd. ("Michener") and T & E Ventures Inc. ("TEV") outlined in the TEV Financing Agreement, as defined in the Affidavit of Tyrone Schneider, sworn August 10, 2010 (the "Schneider Affidavit"), with respect to Michener and the Michener Project, as defined in the Schneider Affidavit;
- (b) authorizing the Medican Group to perform all of its obligations under the TEV Financing Agreement with respect to the Michener Project;
- (c) granting the TEV Charge, as defined in the Schneider Affidavit, over the Michener Project, and ranking in priority to the DIP Lender's Charge, the Administration Charge and the Directors' Charge, as defined in the Initial Order (the "Initial Order") granted in these proceedings on May 26, 2010 (the "CCAA Charges"); and
- (d) authorizing the use of the first advance made under the TEV Financing Agreement to pay out existing creditors of the Michener Project.
- 3. An Order, substantially in the form of the Order attached hereto as Schedule "B", approving the sale of commercial property held by R7 Investments Ltd. ("R7") to Cypress College.
- 4. An Order, substantially in the form of Order attached hereto as Schedule "C", approving the purchase and sale agreement between Medican (Sylvan Lake) Developments ("Sylvan Lake") and Lamont Land Inc. ("Lamont") outlined in the Lamont Purchase Agreement, as defined in the Schneider Affidavit, with respect to Sylvan Lake and the Sylvan Lake Dipert Lands, as defined in the Schneider Affidavit.
- 5. An Order, substantially in the form attached hereto as Schedule "D" for the following relief:
 - (a) granting an extension to the Stay Period granted in these proceedings under the provisions of the Companies' Creditors Arrangement Act, R.S.C. 1985, c. C-36,

- as amended ("CCAA") from the current expiry date of August 12, 2010 to September 30, 2010;
- (b) extending the DIP Lending Facility to \$3.5 million, and authorizing an additional draw of \$1.0 million under the existing DIP Lending Facility; and
- (c) declaring that the term "Canadian Imperial Bank of Commerce" used in the Initial Order, includes the entity "CIBC Mortgages Inc.".
- 6. Such further and other relief as counsel may advise and this Honourable Court deems just.

AND FURTHER TAKE NOTICE that the grounds for this application are as follows:

The Michener Project

- 7. The Michener Project is a Development Project that comprises a three phase condominium development project located in Red Deer, Alberta. The Michener Project was originally financed by Paragon Capital Corporation ("Paragon") and 933680 Alberta Ltd ("933"). The Medican Group received an offer to refinance the Michener Project from TEV.
- 8. The proposed financing is necessary to complete the Michener Project, and is consistent with the Medican Group's efforts to work with the Monitor, and its creditors, to finance and complete uncompleted development projects where it is anticipated there is recoverable value for the Medican Group's stakeholders.
- 9. The terms of the proposed financing is, in the view of the Medican Group and its advisors, fair, reasonable, and necessary for the Medican Group to maximize value for its stakeholders.
- 10. The Monitor approves the proposed financing and the TEV Charge Order, and supports this application.
- 11. The beneficiaries of the CCAA Charges all consent to the relief sought under the TEV Charge Order, as do the secured lenders to Michener Project.

The R7 Investments Ltd. Sale

- 12. The Medican Group received an offer to purchase a residential building located in Medicine Hat held by R7 (the "7th Street Property") from Cypress College (the "7th Street Offer"). The 7th Street Offer is comparable to the appraised value for the 7th Street Property. The sale will see the mortgage holder paid out in full with equity available to the Medican Group's stakeholders.
- 13. The Monitor approves of this sale and supports this application.

The Sylvan Lake – Dipert Lands

- 14. The Sylvan Lake Dipert Lands are bare lands located in Sylvan Lake, Alberta. Lamont offered to purchase the Sylvan Lake Dipert Lands for \$5.2 million. The Lamont Purchase Agreement is comparable to the advised listing price recommended to the Monitor by Cushman Wakefield Ltd.
- 15. The Monitor approves of this sale and supports this application.

The Stay Extension

- 16. Since June 11, 2010, the following steps in the restructuring of the Medican Group have occurred:
 - (a) the Medican Group obtain an approval and vesting order which allows it to continue to sell condominium units such that funds will be available to the stakeholders of the Medican Group;
 - (b) the Medican Group and the Monitor implemented a Claims Process with a Claims Bar Date of July 30, 2010;
 - (c) the Medican Group obtained an order to facilitate financing from MCAP to complete the Legends Project in Winnipeg, Manitoba;
 - (d) the Medican Group obtained an order to commence and, with the assistance of the Monitor, has commenced, a sales process with respect to Phases 2 & 3 of the Terwillegar Project in Edmonton, Alberta;

- (e) the Medican Group obtained an order to commence and, with the assistance of the Monitor, has commenced, a sales process with respect to Phases 2 & 3 of the Axxess Sylvan Lake Project;
- (f) the Medican Group obtained court approval of financing from (i) CIBC for the completion of Phase 4A of the Sanderson Project in Calgary, Alberta and (ii) Macdonald Canvas Properties Ltd. for the completion of Phases 3 & 4 of the Canvas (Calgary) at Millrise Project in Calgary, Alberta; and
- (g) the Monitor, upon the request of the Company, implemented an examination process so that it can investigate the veracity of certain transactions of the Medican Group.
- 17. An extension of the Stay Period to September 30, 2010 is necessary to continue the restructuring of the Medican Group and to allow the Medican Group to continue to stabilize its operations, communicate with its stakeholders, prioritize its projects, develop a viable plan to enable the Medican Group to emerge from these proceedings for the benefit of all stakeholders.
- 18. The Medican Group continues to work closely with the Monitor and all of the Medican Group's stakeholders in all respects and the Monitor supports the proposed relief and stay extension.
- 19. The Medican Group is working in good faith and with due diligence in these proceedings and believe it is within the best interests of the Medican Group and all stakeholders to continue in these proceedings as outlined above.

Additional Funding under the DIP Facility

- 20. Additional funding under the existing DIP Lending Facility (as attached to the Initial Affidavit of Wesley Reinheller, sworn May 25, 2010 filed herein these proceedings) is fair and reasonable in the circumstances on the basis that:
 - (a) it continues to be required only for essential and anticipated needs of this restructuring;

(b) it is advanced to a new management team that is working very closely with its

advisors and the Monitor; and

(c) it is, when allocated throughout the portfolio of the Medican Group's property,

not burdensome to any particular stakeholder.

21. The Monitor supports the additional draw on the DIP Facility.

22. CIBC has requested clarification that the reference in the Initial Order to "Canadian

Imperial Bank of Commerce" includes "CIBC Mortgages Inc.". This is consistent with the

intention of the Applicants and the Monitor and neither the Applicants nor the Monitor object to

such a clarification.

AND FURTHER TAKE NOTICE that the Applicants will rely upon the Affidavit of

Tyrone Schneider, dated August 10, 2010, filed; the Fourth Report of the Monitor, dated August

10, 2010 filed; the pleadings and other materials filed herein; the provisions of the Companies'

Creditors Arrangement Act (Canada) and the Alberta Rules of Court; and such further and other

material as counsel may advise and this Honourable Court may permit.

ORDER

(TEV Charge – Michener Project)

UPON the application of the Petitioners in these proceedings (collectively, the "Medican Group"); AND UPON having read the Notice of Motion of the Petitioners, dated August 10, 2010, the Affidavit of Tyrone Schneider, dated August 10, 2010 (the "Schneider Affidavit"), the Fourth Report of the Monitor, dated August 10, 2010, the Affidavit of Ronica Cameron,

Service

- 1. The time for service of notice of this application is abridged to the time actually given and service of the Notice of Motion and supporting material as described in the Service Affidavit is good and sufficient, and this hearing is properly returnable before this Honourable Court today and further service thereof is hereby dispensed with.
- 2. All capitalized terms not otherwise defined in this Order shall have the meaning ascribed to them in the Initial Order granted in these proceedings on May 26, 2010 (the "Initial Order").

Approval of the TEV Financing Agreement

- 3. The financing agreement among TEV and the Medican Group, dated August 4, 2010 and attached as Exhibit "A" to the Schneider Affidavit (the "TEV Financing Agreement") is hereby approved.
- 4. The Medican Group and the Monitor are hereby authorized and directed to do all things reasonably necessary to implement, and perform all of their respective obligations under, the TEV Financing Agreement.

Approval of the TEV Charge

5. As security for monies advanced by TEV to the Medican Group pursuant to the TEV Financing Agreement, a charge is hereby granted on all of the undertaking, property and assets of Medican (Red Deer – Michener Hill) Developments Ltd. used on, in, or in connection with the development project known as Red Deer Sierras Michener Hill in Red Deer, Alberta (the "Michener Project") in favour of TEV (the "TEV Charge") ranking in priority to the DIP Lender's Charge, the Administration Charge, and the Directors' Charge.

- 6. The Monitor and the Medican Group are hereby authorized to distribute the Initial Advance, as that term is defined in the TEV Financing Agreement, as follows:
 - (a) firstly, to Paragon Capital Corporation in respect of all amounts owing to it in connection with its financing of the Michener Project;
 - (b) secondly, to 933680 Alberta Ltd. in respect of all amounts owing to it in connection with its financing of the Michener Project;
 - (c) thirdly, to all creditors for all amounts owed to them in respect of goods and services that such creditors supplied to the Michener Project; and
 - (d) fourthly, the sum of \$200,000 to the Monitor to apply in favour of the Charges in such manner as the beneficiaries of the Charges may agree.
- 7. Upon the distributions described in the foregoing paragraph being made the Monitor shall file a certificate with this Honourable Court confirming that such payments have been made which certificate, when presented to the Registrar of Land Titles in and for the Province of Alberta (the "Registrar") along with a certified copy of this Order, shall be the sole authority for the Registrar to discharge any encumbrances registered by any party receiving a payment pursuant to paragraph 6 hereof against the Michener Project.

Miscellaneous

8. The TEV Financing Agreement and the TEV Charge shall be valid and enforceable and not be rendered invalid or unenforceable and the rights and remedies of the parties thereto shall not otherwise be limited or impaired in any way by: (i) the pendency of these proceedings and the declaration of insolvency made herein; (ii) any Bankruptcy Order sought or issued pursuant to the *Bankruptcy and Insolvency Act* (Canada) (the "BIA") in respect of any of the Medican Group or any assignment in bankruptcy made or deemed to be made in respect of any of the Medican Group; or (iii) any negative covenants, prohibitions or other similar provisions with respect to borrowings, incurring debt or the creation of encumbrances, contained in any existing agreement, lease, sub-lease, offer to lease or other arrangement which binds any of the Medican

Group (a "Third Party Agreement"), and notwithstanding any provision to the contrary in any Third Party Agreement:

- (a) neither the creation of the TEV Financing Agreement, the creation of the TEV Charge, nor the execution, delivery or performance of the TEV Financing Agreement shall create or be deemed to constitute a breach by any of the Medican Group of any Third Party Agreement to which it is a party; and
- (b) the parties to the TEV Financing Agreement shall not have liability to any person whatsoever as a result of any breach of any Third Party Agreement caused by or resulting from the creation of the TEV Charge or the execution, delivery or performance of the TEV Financing Agreement.
- 9. Notwithstanding: (i) the pendency of these proceedings and the declaration of insolvency made in these proceedings, (ii) any Bankruptcy Order sought or issued pursuant to the BIA in respect of any of the Applicants or any assignment in bankruptcy made or deemed to be made in respect of any of the Applicants, and (iii) the provisions of any federal or provincial statute, the TEV Financing Agreement and the TEV Charge shall constitute legal, valid and binding obligations of the Medican Group enforceable against them in accordance with the terms thereof, and the payments made by the parties pursuant to this Order, the TEV Financing Agreement, or the TEV Charge do not and will not constitute settlements, fraudulent preferences, fraudulent conveyances or other challengeable or reviewable transactions or conduct meriting an oppression remedy under any applicable law, and shall not constitute advances under *The Builders' Liens Act* (Alberta) nor be subject to any builder's lien registered at the date of this Order or thereafter.
- 10. Notwithstanding any other provision of this Order, the rights and remedies of the parties under the TEV Financing Agreement shall be subject to the terms of this Order, the Initial Order, including the stay of proceedings, and all other Orders made in these proceedings.
- 11. No action or proceeding may be commenced against a party to the TEV Financing Agreement by reason of any such party having entered into the TEV Financing Agreement or having performed the obligations thereunder without leave of this Court having been obtained on seven days' notice to such party, the Medican Group, and the Monitor.

- 12. The Medican Group, TEV and the Monitor or any party to the TEV Financing Agreement are at liberty to apply for such further advice, assistance and direction as may be necessary to give full force and effect to the terms of this Order.
- 13. The Medican Group shall serve, by courier, facsimile transmission, e-mail transmission, or ordinary post, a copy of this Order on all parties present at this application and on all parties who received notice of this application or who are presently on the service list established in these proceedings, and service on any or all other parties is hereby dispensed with. Service effected as aforesaid shall be good and sufficient service.
